On 4/11/2024 at about 1053hrs, I was driving CNB vehicle SLL 9157S (QX1310X) proceeding towards Changi Airfreight Cargo Complex (CAC), located at No 6 Airline Road, to take over a parcel case from the ICA Duty Officer.

At the traffic light junction of Pasir Ris Drive 3 and Loyang Way, as the traffic light turned green, I was moving off and about turn right when the vehicle in front of me, a grey-colored Toyota Auris hatchback, bearing licence plate SKR 2515T suddenly braked. I couldn"t brake in time and thus, hit onto the rear

bumper of SKR 2515T. I got out of the car, as did the other driver and we both took photographs of the collision. We then agreed to move off to another location to exchange particulars as we didn"t want to hinder the traffic movement at the junction.

We then drove off to a nearby multi storey carpark, where we exchanged particulars.

The driver of SKR 2515T was ascertained to be Nur Aisyah Binte Zainudin of NRIC S9323196A (DOB: 28/6/1993), contact number 81897212. I asked her if she sustained any injuries from the collision and she replied she did not.

There were no other occupants in her vehicle.

I also noticed that vehicle SKR 2515T sustained some rear bumper damage.

As for SLL 9157S, the front licence plate holder was damaged.

I also informed her that SLL9157S was a government-owned vehicle.

I then left the location and proceeded towards CAC to take over the parcel case.
