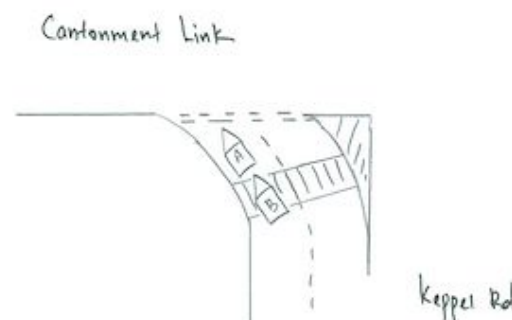

On 4 Nov 2024 around 8pm, I was driving along Keppel Road towards Carbonment Link for home with my wife, Lim Ming Yuan and two daughters when the accident happened.

At that slip road, I stopped for a moment for a pedestrian to cross at the Zebra crossing. Thereafter, I crossed the zebra crossing and had to stop again for a car that was turning into Carbonment Link from my right.

A split second after that car passed, I released the brake and started to move off. Then, I felt a sudden huge bang from the rear of the car and my car jerked forward before I applied emergency brake to stop.

That was when the car SMH2556D hit my car.

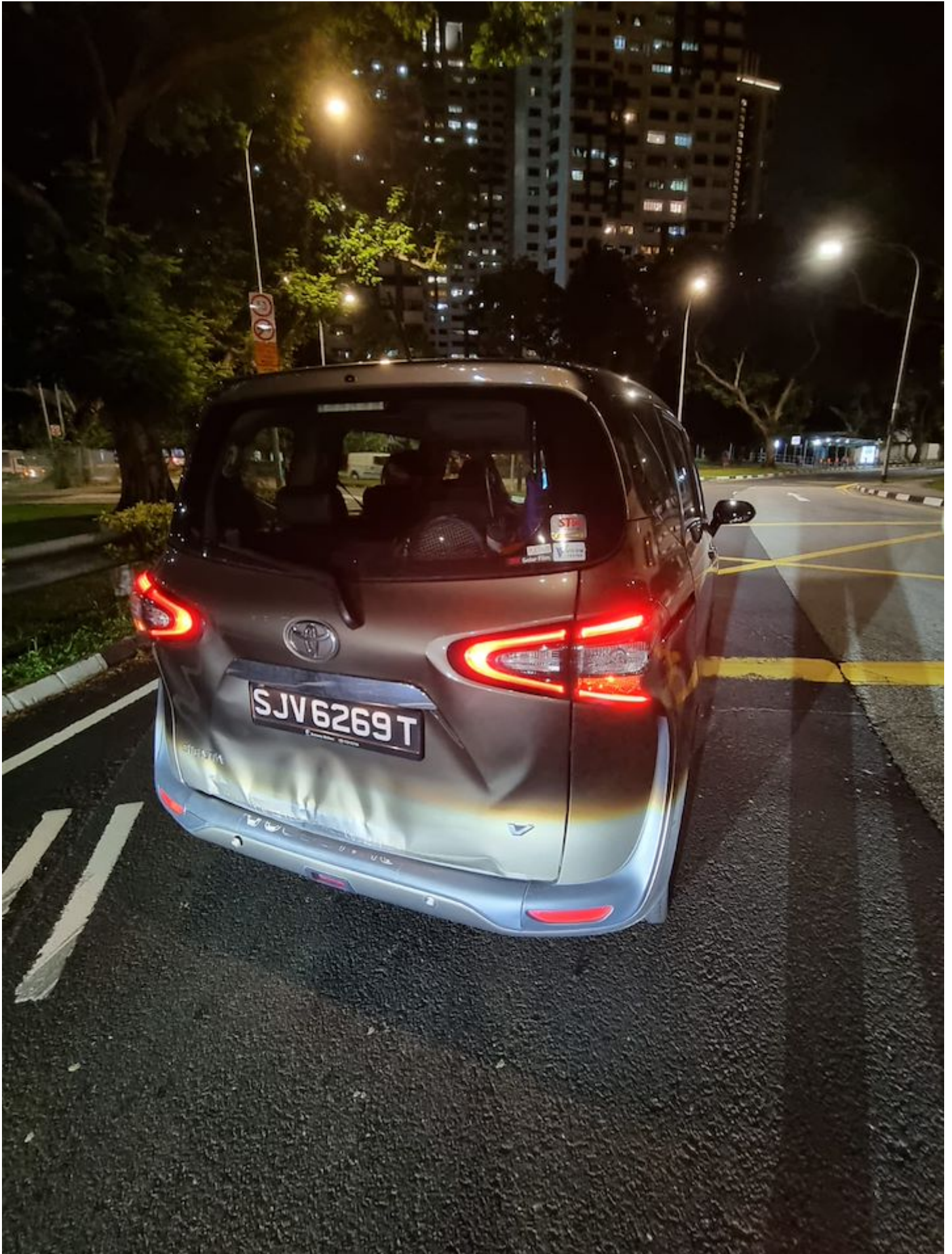


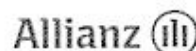
