We refer to your instructions to us to conduct a paper survey of the above vehicle. A prerepair survey was conducted on 30-03-2021, followed by inspection of dismantled parts on 31-03-2021 and resurvey after repairs on 07-04-2021.

The vehicle sustained rear damages during an accident on 29-03-2021.

- 1) According to the driver of GBG 2749 A, the LH wing mirror of his lorry had knocked and broke the rear windscreen of GBC 8781 L.
- 2) The photos taken by reporting centre did not reveal any damages on vehicle GBG 2749 A.
- 3) The rear tail gate, rear bumper and the end panel of GBC 8781 L were badly dented.

These did not appear consistent to damages that could be caused by vehicle GBG 2749 A.
