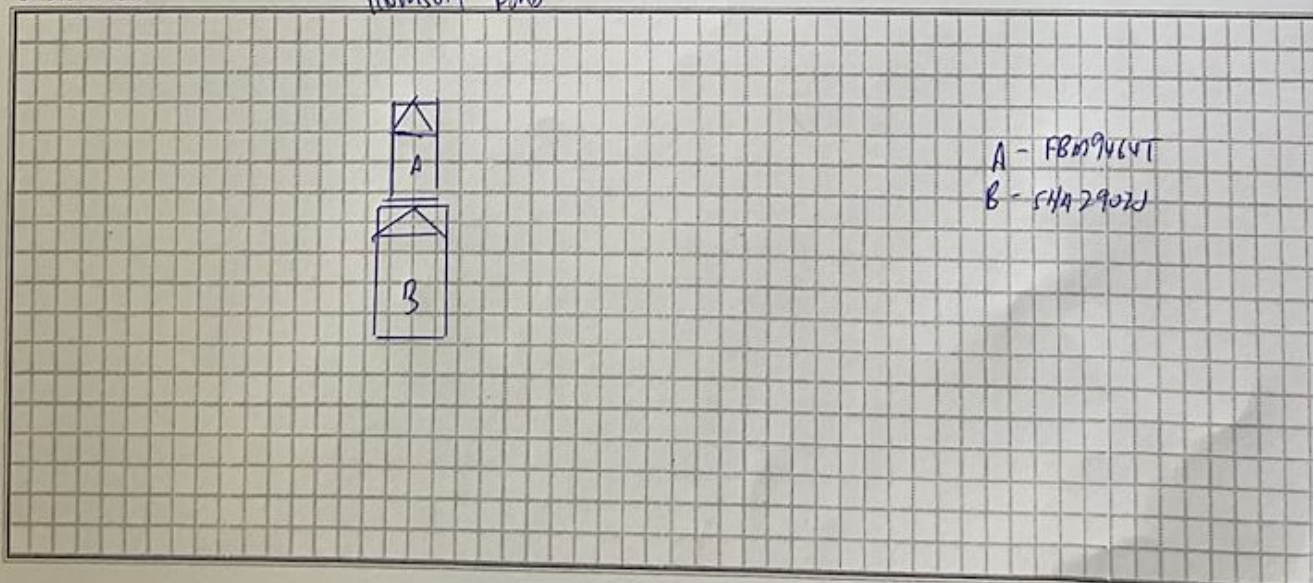

## Describe Circumstance of the Accident


On 26/10/24 at 2115hr, as I was stationing along Thomson Road, 5147902J suddenly collided into my rear.
