Brief Details.

On 26/6/2024 at about 1005hrs I was driving along SLE towards TPE just before Lentor Exit on the 4th lane when I felt an impact from the right rear side of my vehicle when I was at least half a car distance ahead of the truck. 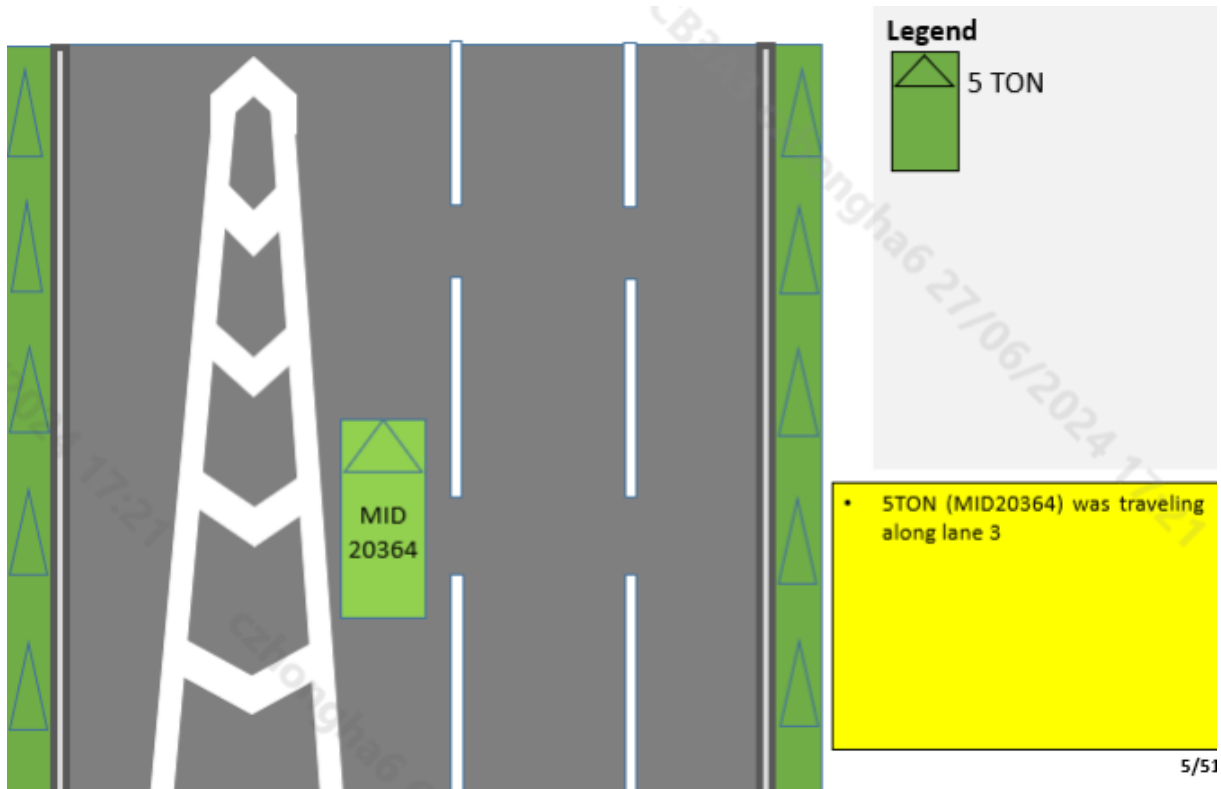

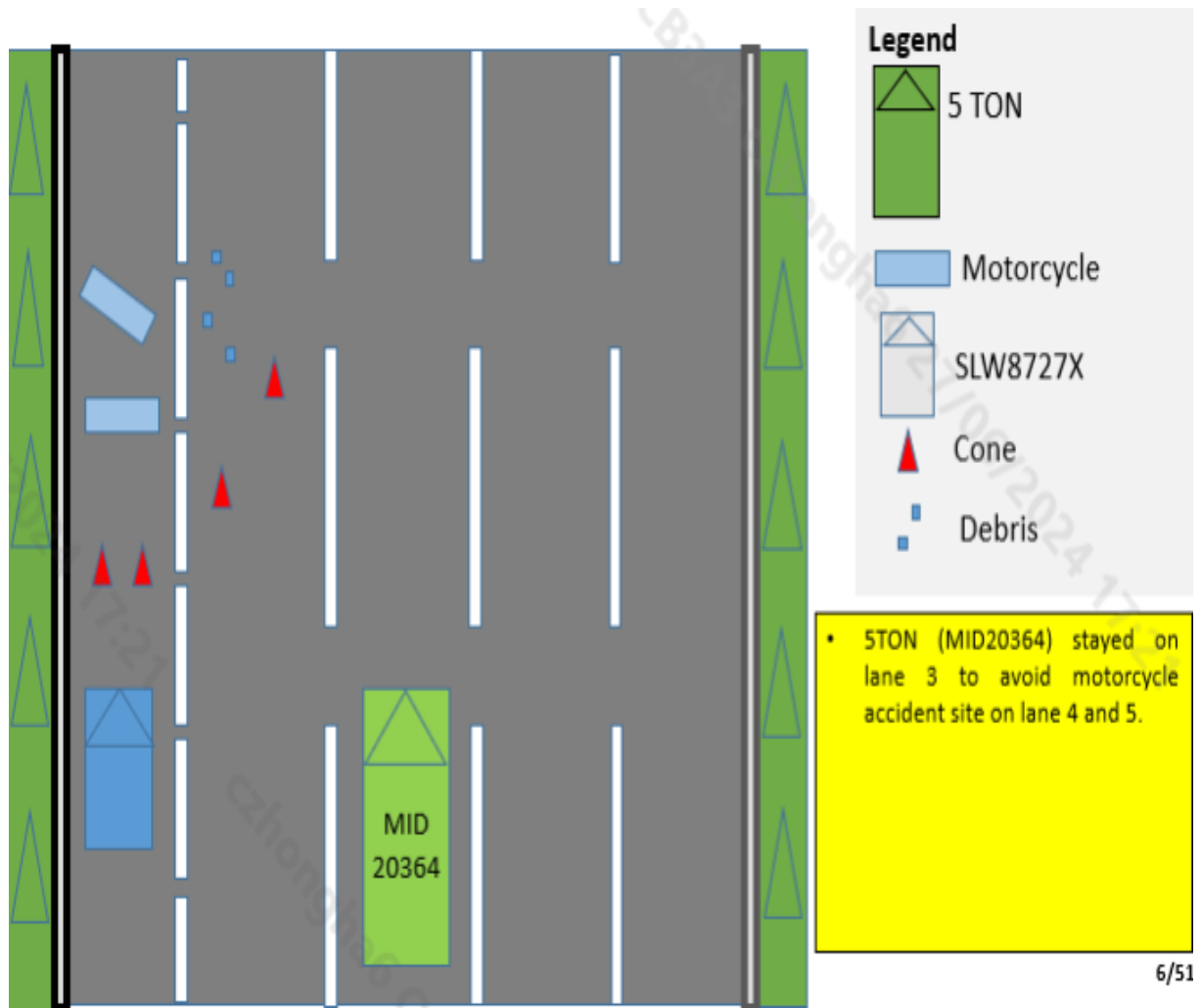

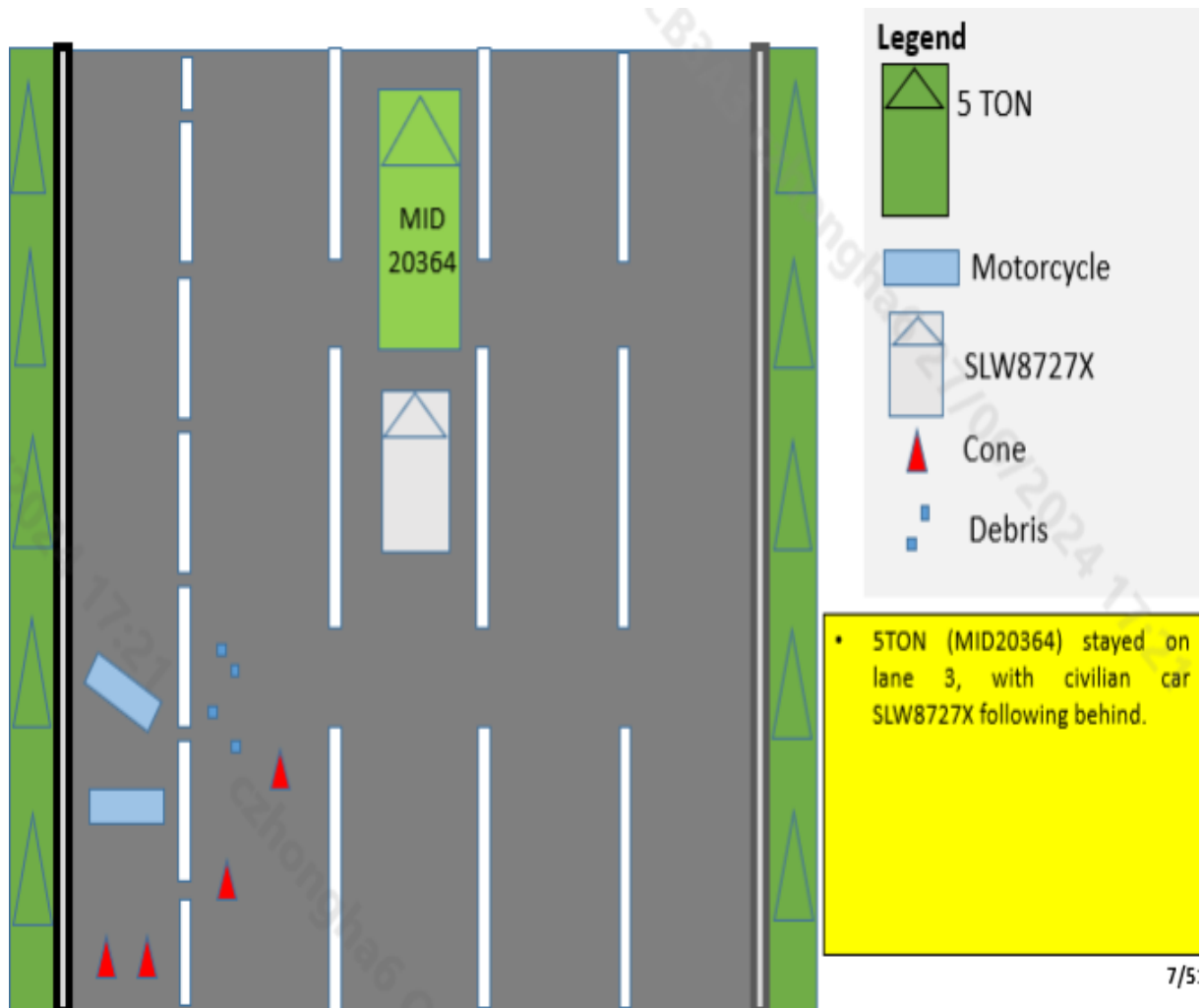

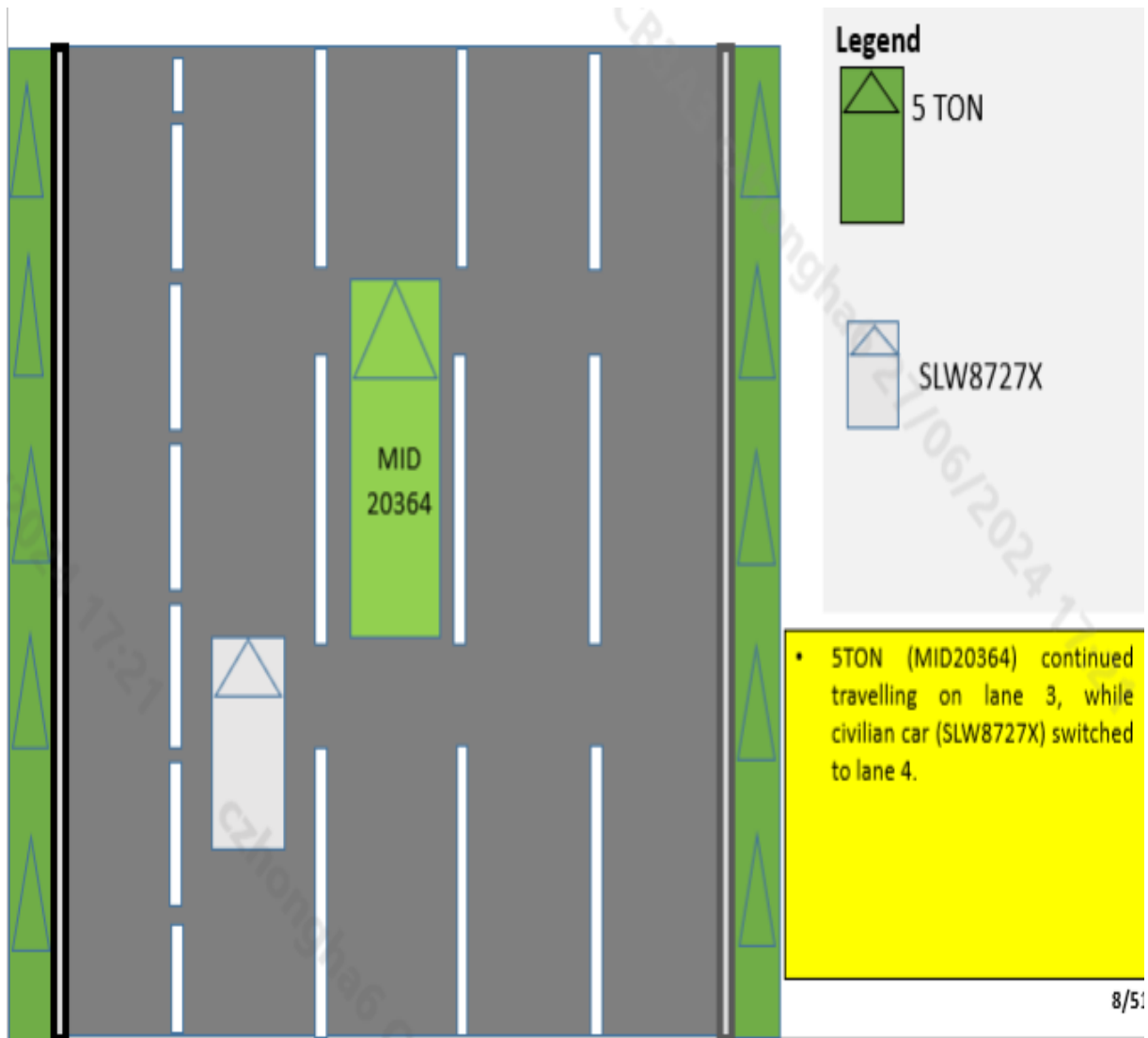

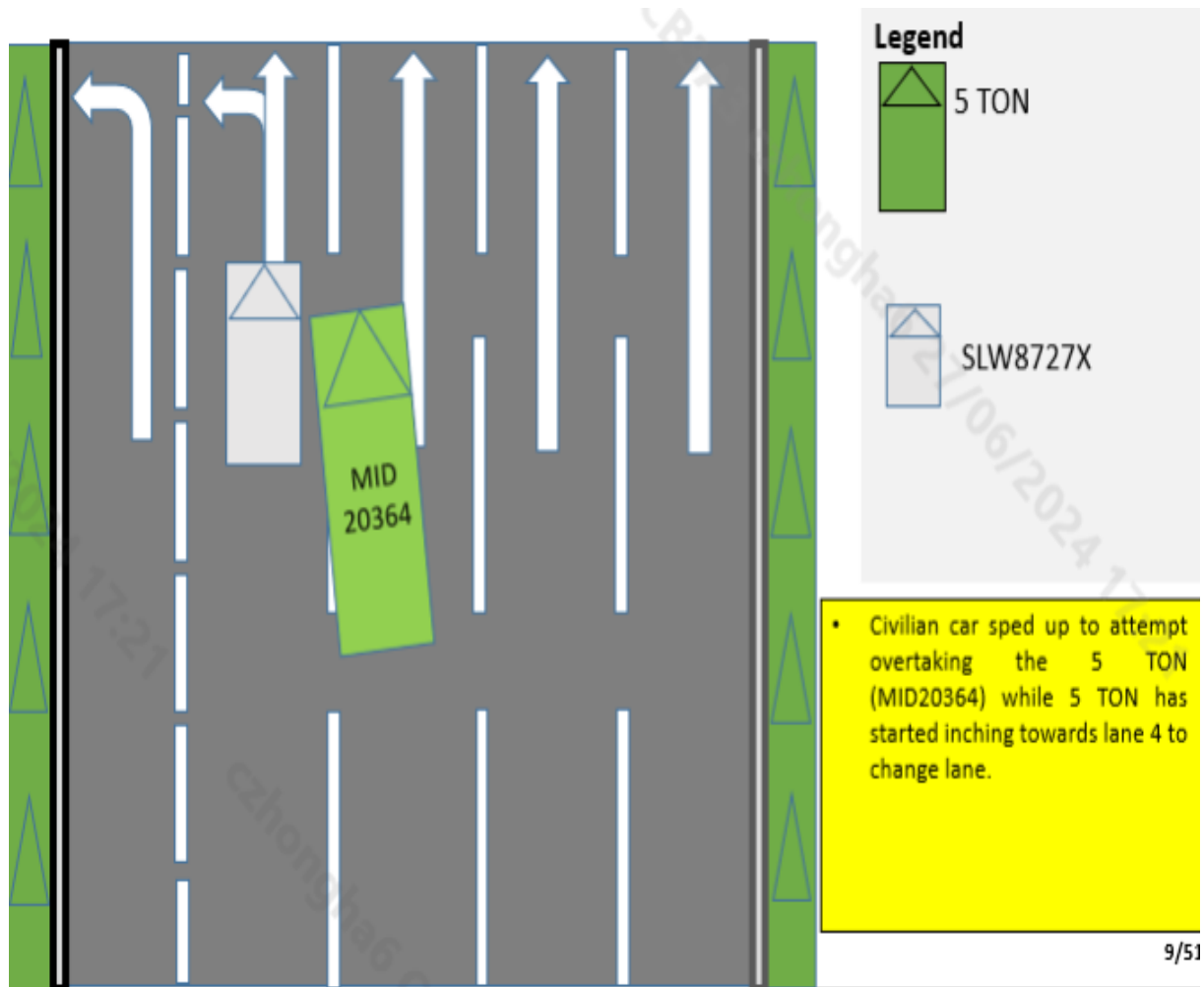

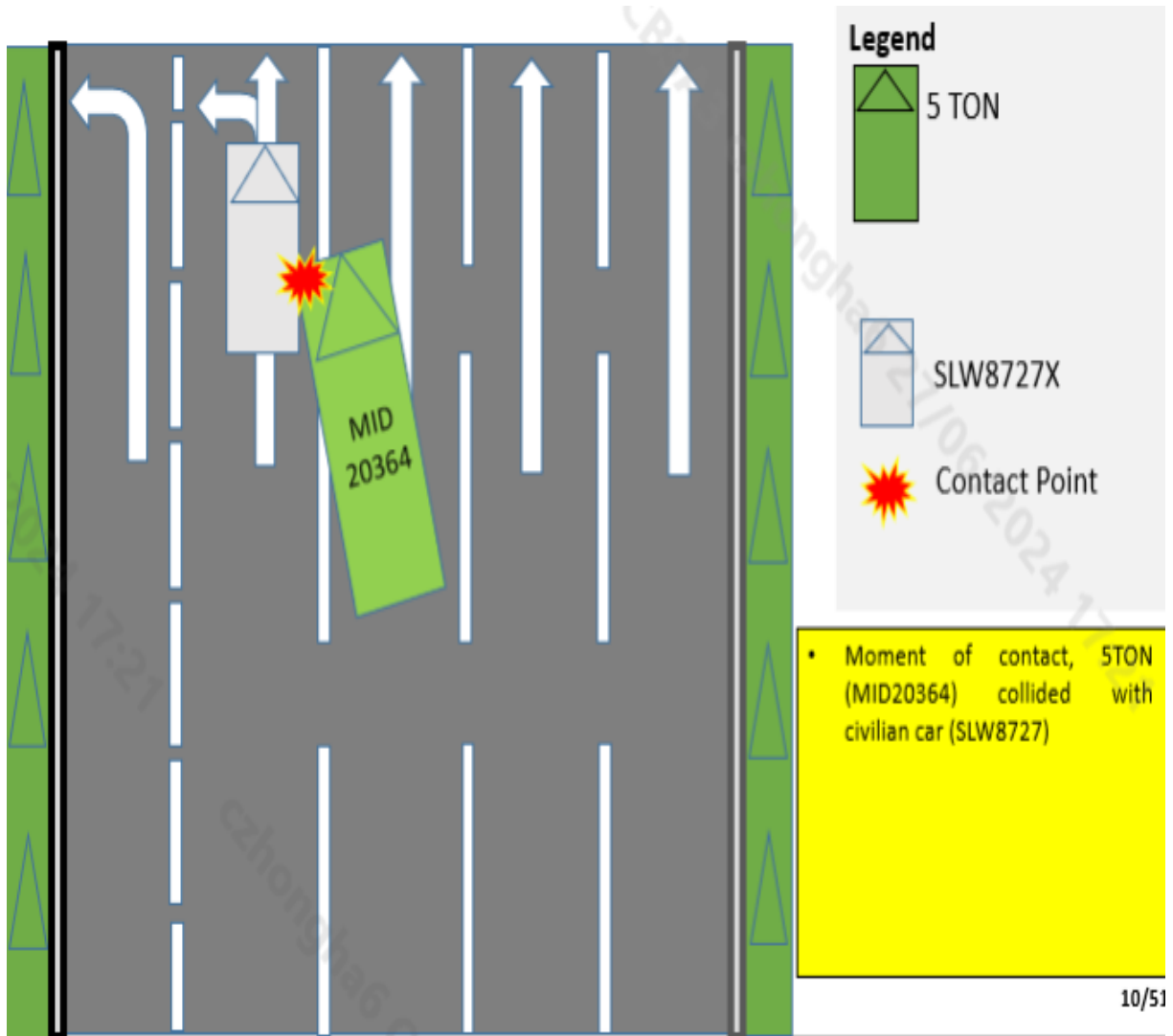
