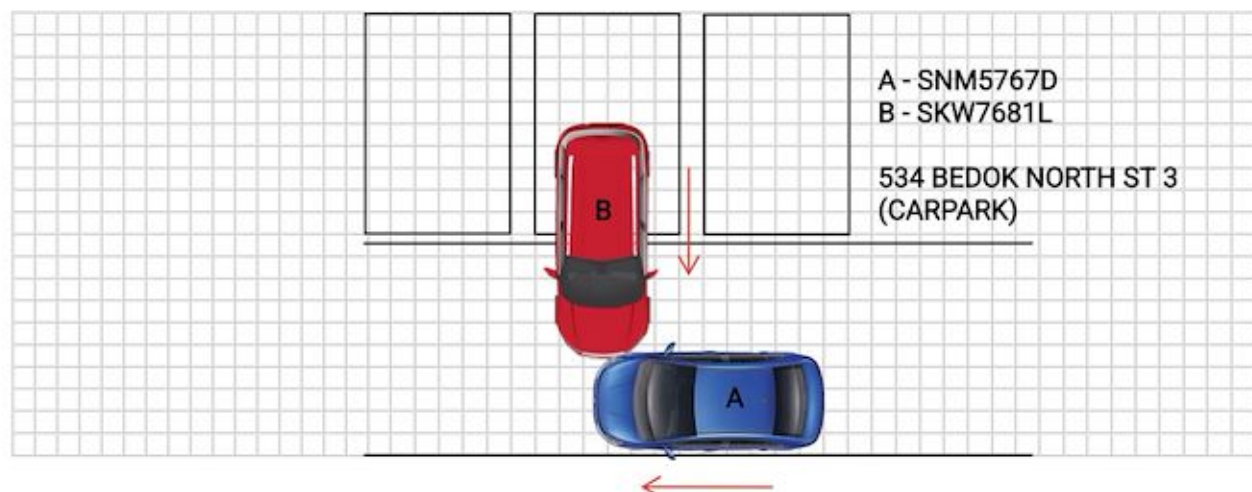
Sketch Plan
