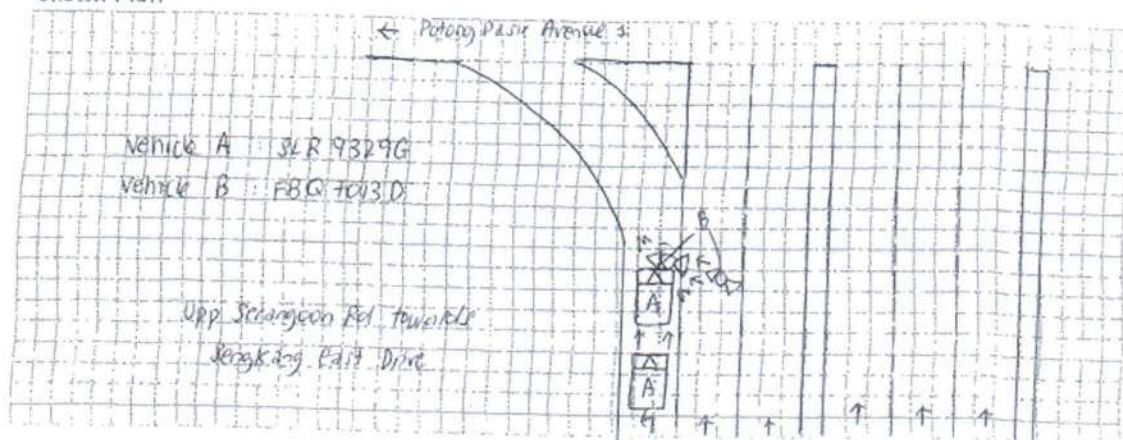

As of above date & time, I was driving my vehicle (SLR 9329 G) along upp Serangoon Rd towards Jengkat Fast Drive on the left lane of a 3 Lane Rd.
