WHILE TURNING, VEHICLE B (SLA4418E) DRIVING FROM THE OPPOSITE DIRECTION BEAT RED LIGHT. AS A RESULT, VEHICLE B FRONT PORTION COLLIDED ONTO MY VEHICLE LEFT PORTION.

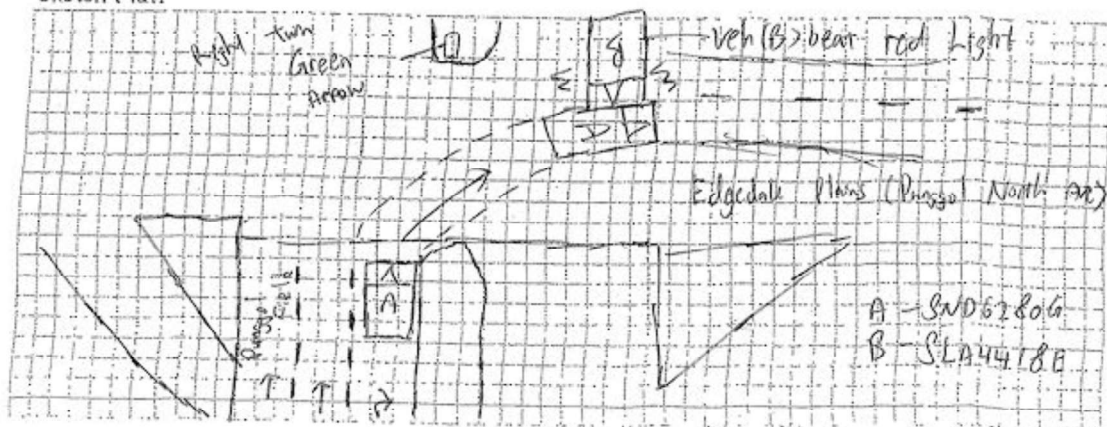
