Thanks for the list of items related to the cost of repair.

We went through the list carefully and realised that the motorcycle had undergone a major repair, including changing the parts that are not caused by our fault/the accident.

Frankly speaking, we got a shock when we were informed on the cost of repair \$1250+, our driver was reversing company van and hitting a motorcycle which was parking/still behind it. The collision was not strong, yet the cost of repair could hit \$1250+.

Please find the attached photos taken by the claimer, the accident had caused damages/scratches to the motorcycle covers, others were still in good condition. Understand from our driver that the motorcycle could still function after the accident, not to the extent to be on tow.


