After that traffic police arrive at the scene. After the collision my lorry sustain some damage at the trailer compartment and the car sustain serious damage as the car right side front being torn apart and the car right rear had major dent.

Brief Details.

On 4th January 2023 at about 1100hrs, while I was driving along Tampines Ave 7 under the flyover exiting Loyang near to lamp post 2/1, I was in the left lane and the traffic was moderate. My vehicle was the first vehicle, and, on my right, there was a Malaysian Lorry turning left together. At that point of time, I saw his vehicle was turning too near and cutting into my lane. I horned as to alert the driver of the near collision. Shortly I felt an impact and my car had been forcefully pushed me to the left side causing my vehicle hitting the railing and to an immediate stop. The driver only stopped when he realized that he had involved in an accident.

A while later EMAS came to assist and escalate the matter to the relevant authorities which LTA and Traffic Police involved.
