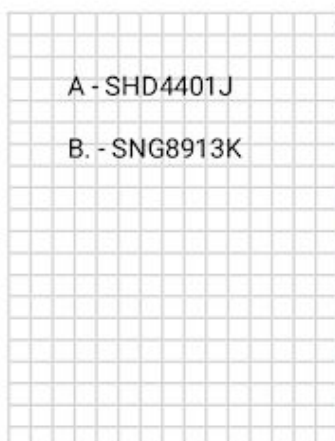
**Sketch Plan**
