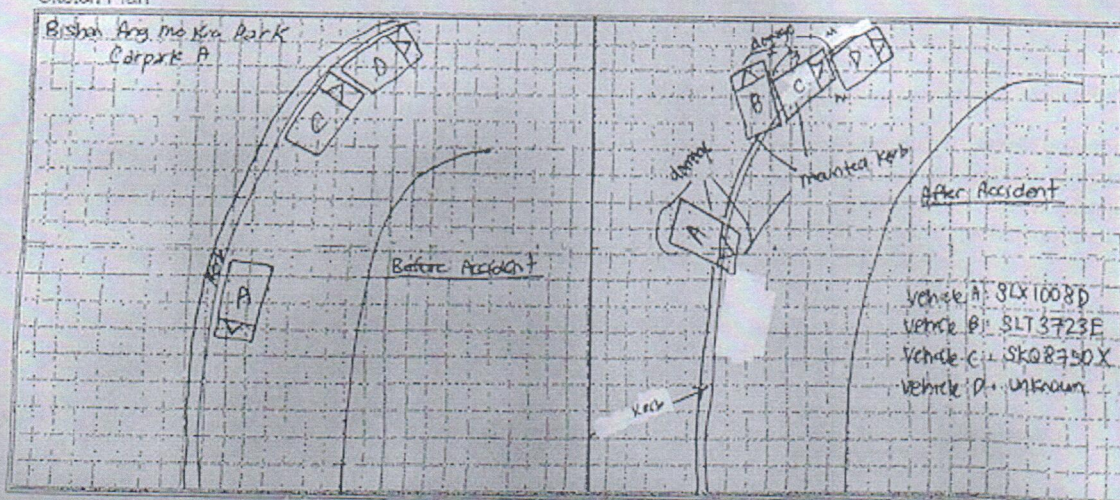

Sketch Plan



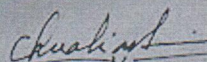

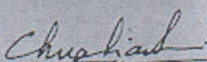
