While traveling straight on the leftmost lane of Bukit Panjang Road, approaching the traffic junction with Pending Road, a private car (SKU8184J) suddenly veered from the right and collided with the front portion of my bus. Upon assessing the situation, I discovered that SKU8184J had been involved in an earlier collision with another vehicle (GBM4461J), which caused SKU8184J to slide left and strike my bus. The collision resulted in cracks on the bus's front right windscreen and front right body panel. No injuries were reported.

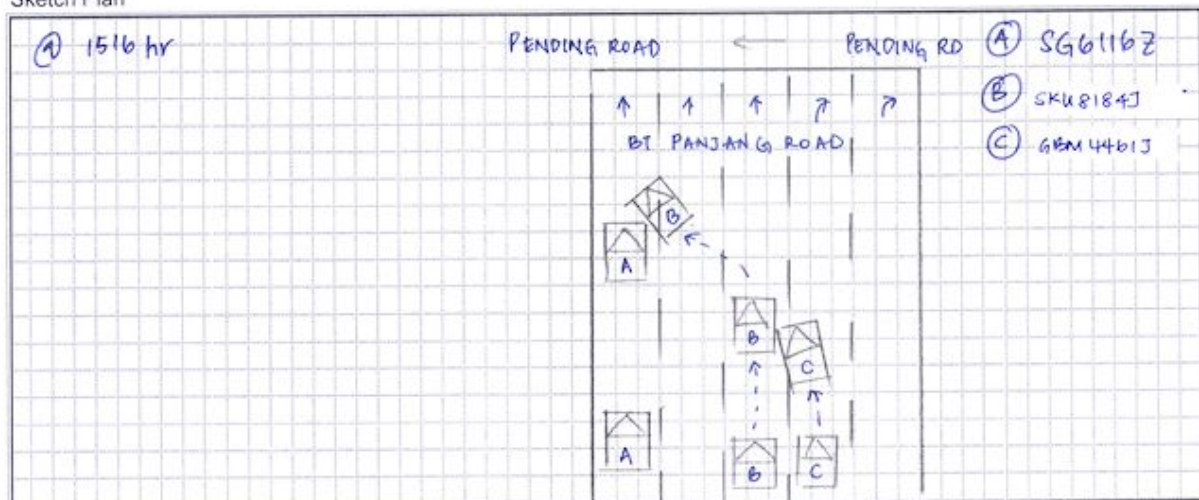
