Brief Details.

On the 20/11/2024 at about 1000hrs, I was riding my motorcycle Plate number SU55020L going to work as I just entered Singapore from Johor Bahru. While riding at BKE Bukit Timah going towards PIE(Changi), I got hit by a motorcycle plate number FBA 7636R. I was riding on Lane 2 and he was riding on Lane 1 when he decided to enter my lane and side sweep my bike. We both fell on the ground which resulted in injury.

Passer by assisted on calling the Ambulance and Traffic Police which they attended to me and conveyed me to Ng Teng Fong General Hospital. I received 10 days Medical Certificate dated from 20/11/2024 - 29/11/2024. The injury I sustain is a lot of abrasions on both of my hands and legs. My bike is also damaged due to the accident, it has a broken fork, left head light broken and back of my bike is also damage.
