Describe Circumstance of the Accident

On the 3rd Oct around 6:30pm I was driving my car along Madras St and turning right to Dalhousie Ln. In front there was another car going when the driver put his blinker and stopped suddenly in the left which had double yellow line. The driver's sudden stop took me by surprise and before I could apply my brakes my car hit the rear right side of the front car. On the right side there was a lorry parked and the gap between the two was narrow, as such I could not avoid the impact. I thought the driver of the front car would be stopping at the taxi stand which was few metres in front. Instead the driver chose to stop immediately causing the impact. The impact caused minor damage to the left front guard of my car.
