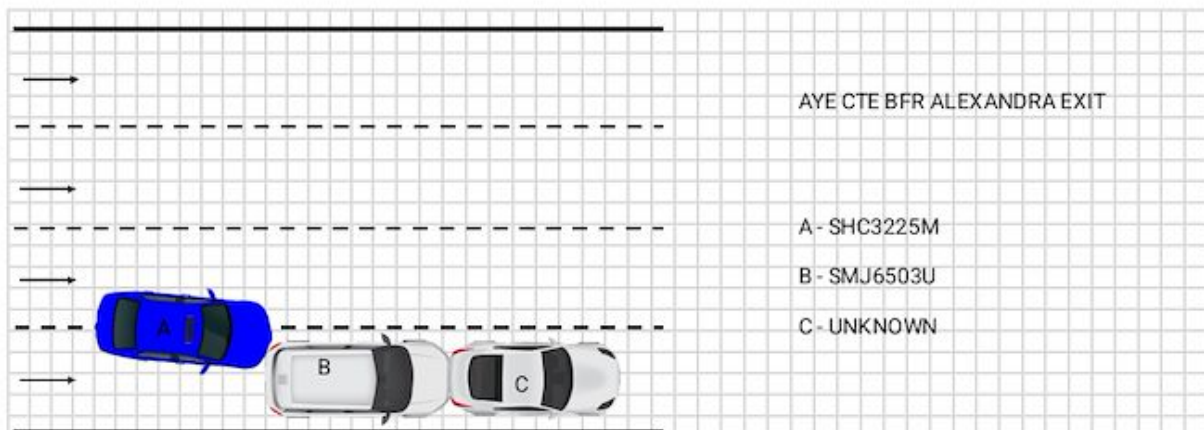
Sketch Plan

Describe Circumstances of the Accident

ON 23/11/2024 AROUND 1805HRS I WAS DRIVING VEHICLE A BEARING REGISTRATION NUMBER SHC3225M ENROUTING FROM JURONG WEST TO MBS FOR WORK PURPOSE. WHILE DRIVING ALONG CTE TWRDS AYE BFR ALEXANDRA EXIT ON LANE 2, THERE WAS A VEHICLE INFRONT OF ME CUTTING LANES SO I DECIDED TO CHANGE MY LANE TO LANE 1.
