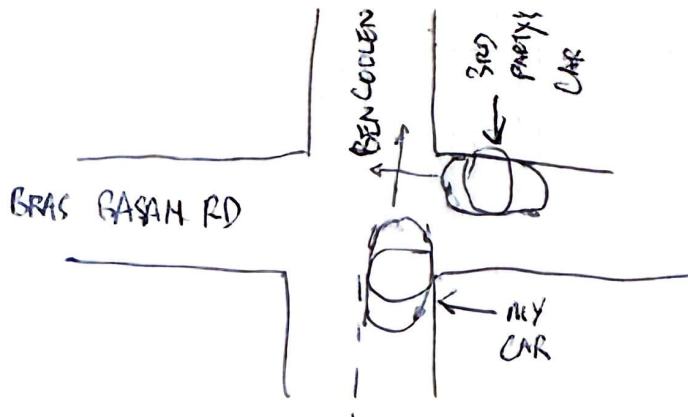

### Sketch Plan






