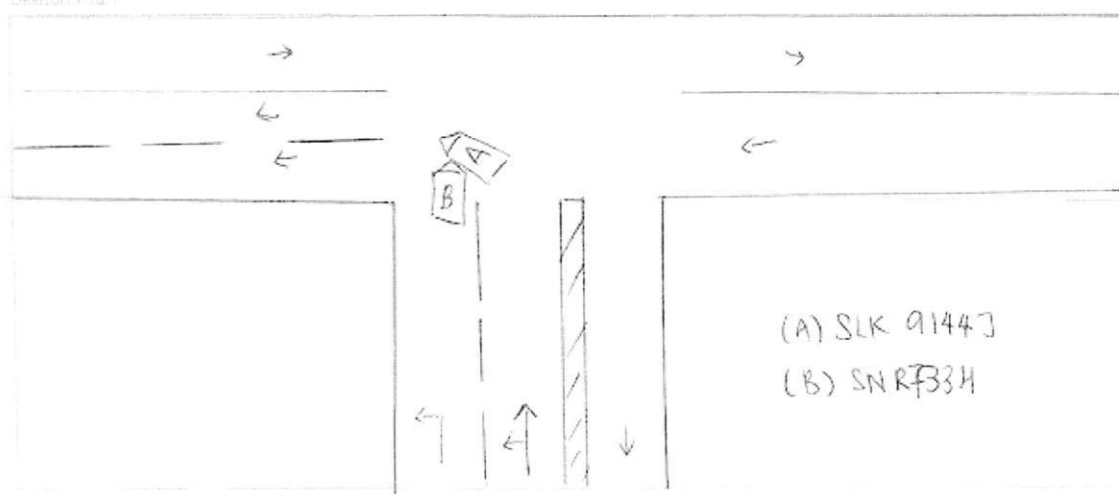

After accident I and the driver come down, I ask him why u hit my vehicle, he told me he wanted to turn right to Hougang ave 8. Video show his hand pointed to right. After accident I felt unwell. On 11/11/2024 I went to W Y Teh family clinic & surgery consult doctor and was given 5 days MC.
