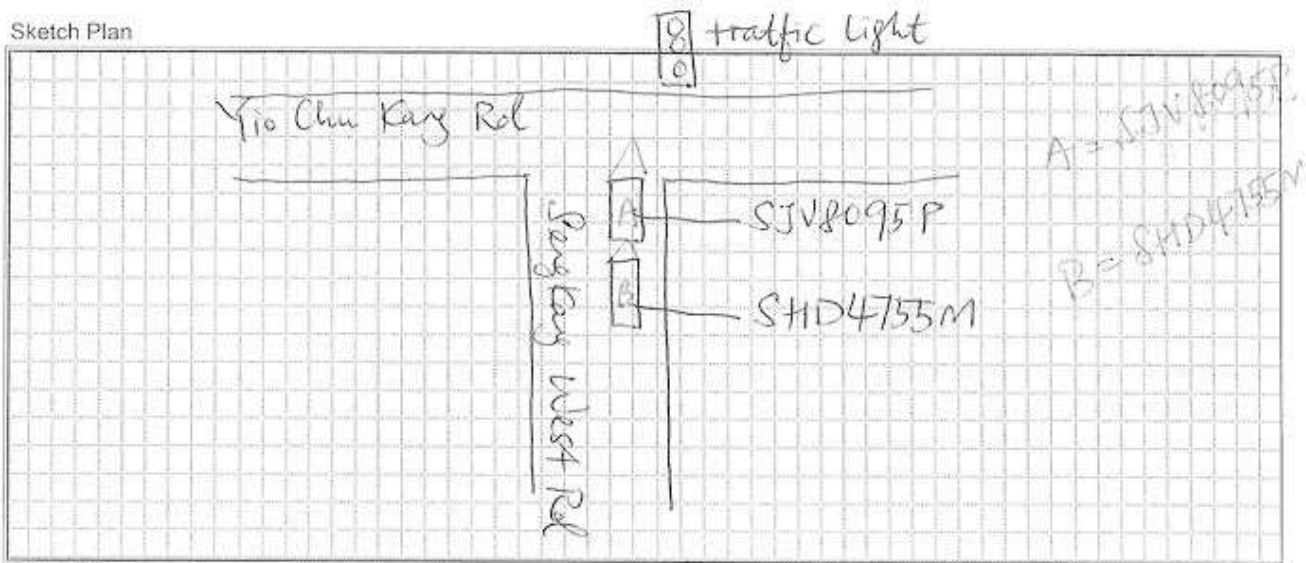

Describe Circumstance of the Accident

On 22/11/2024, at approximately 11pm, I was traveling along Sengkang West Rd, approaching the junction of Yio Chu Kang Rd. I intended to ~~make~~ make a right turn at the junction.

As i approached the traffic light, it changed from green to amber. I prepared to stop and came to a complete stop as the light turned red.

A few seconds after stopping, I heard a loud impact and felt my car being pushed forward. Upon inspection, I realized that a taxi (license plate number SHD 4735 M) had collided with the rear of my vehicle. This caused damage to the back of my car, as documented in the attached photos.
