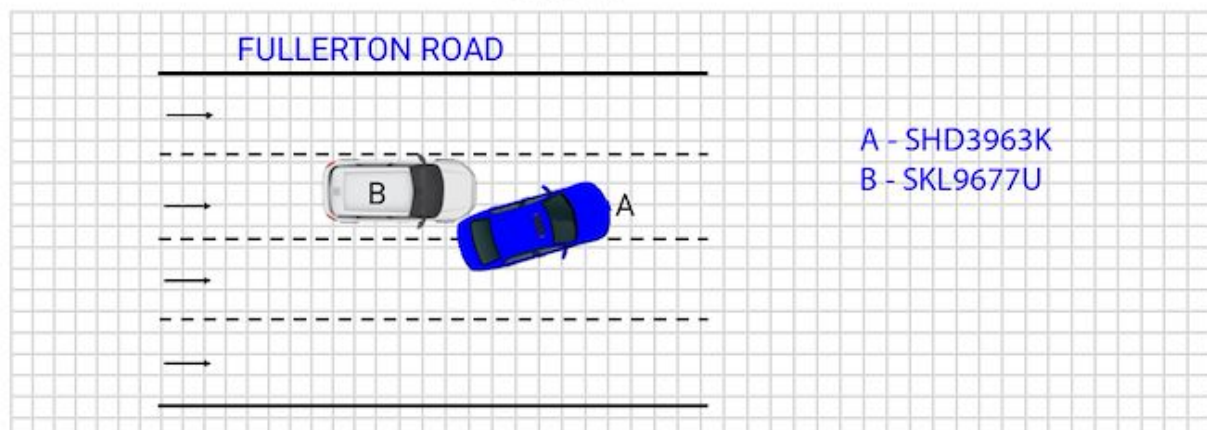
Sketch Plan

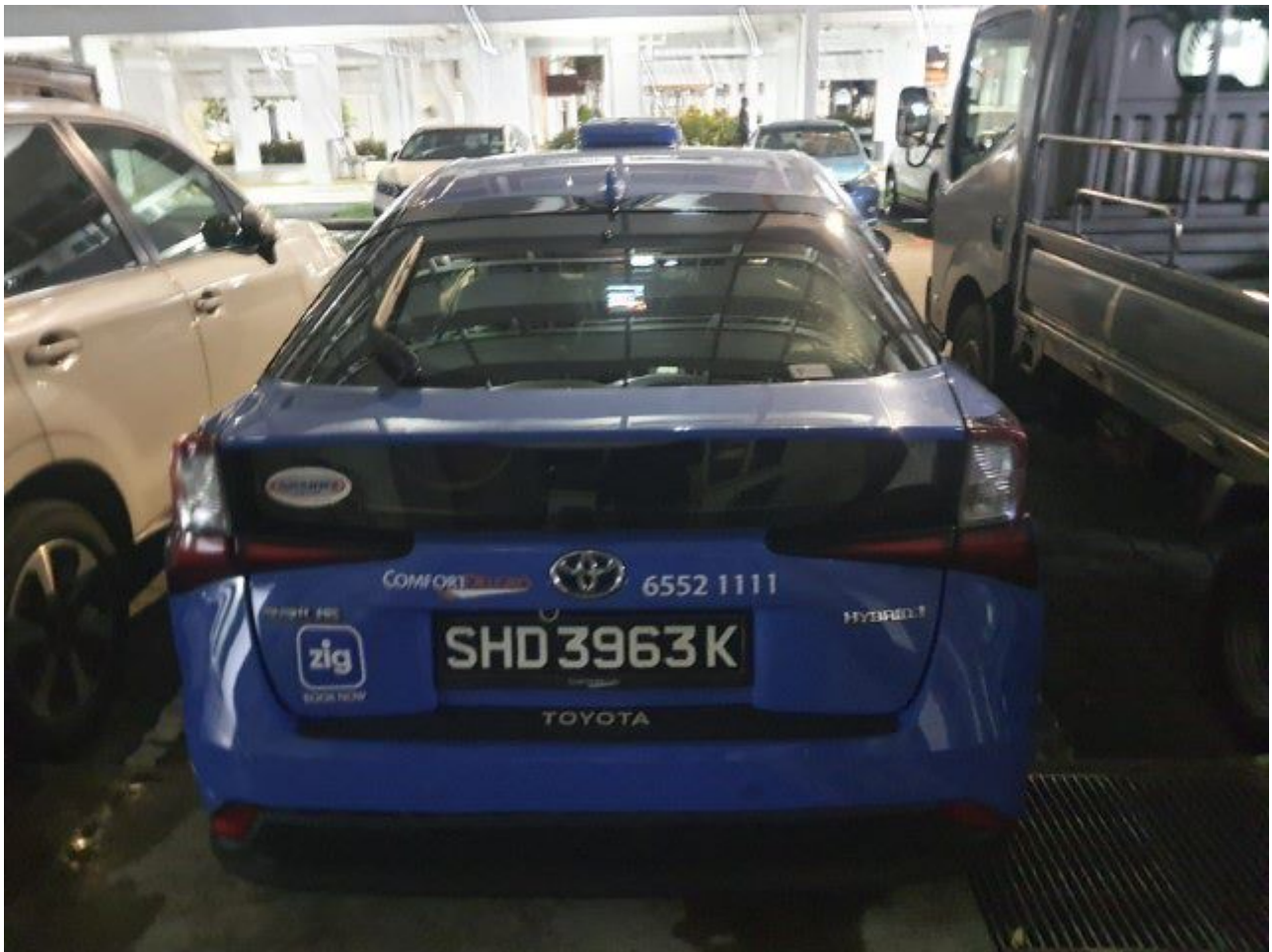

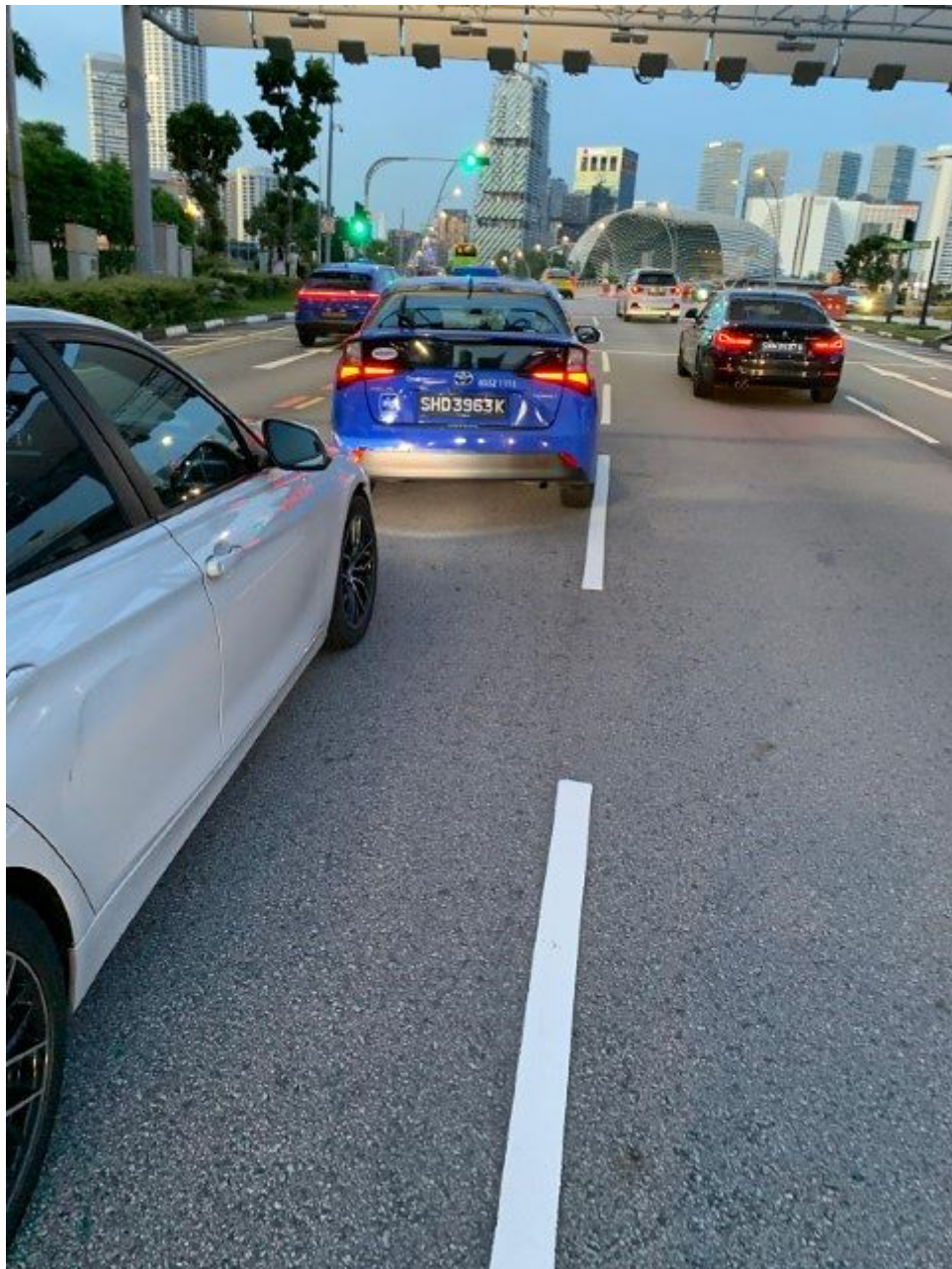
