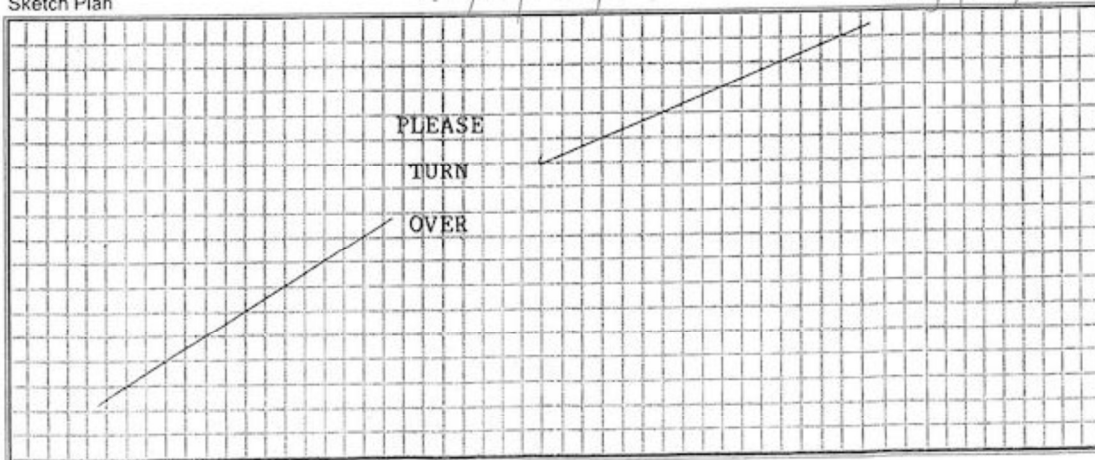

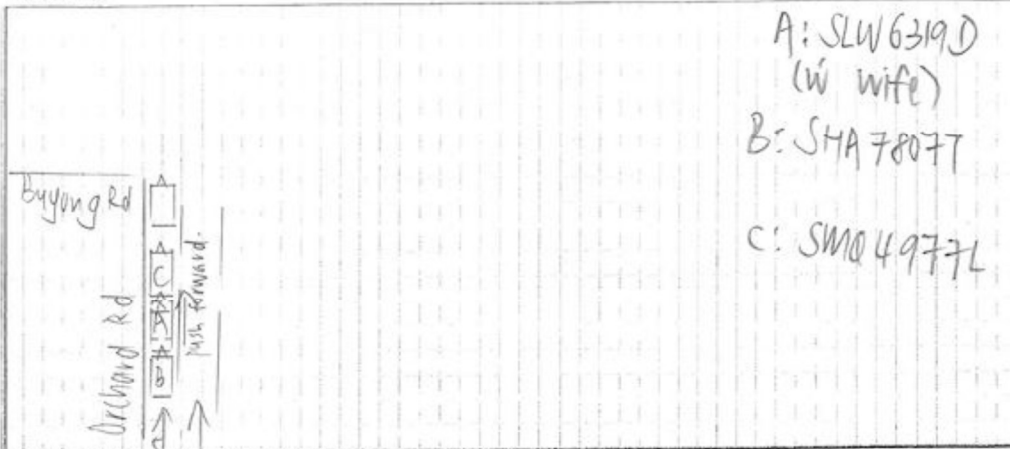

Sketch Plan


