

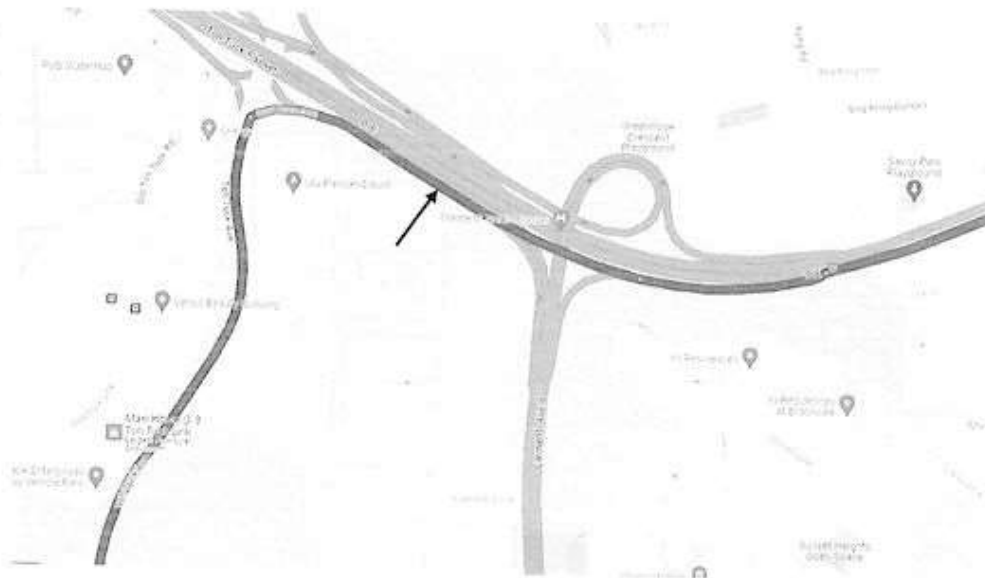

This morning, 26th June 2024 at about 0820am, I exited PIE via exit 27 towards Toh Tuck Avenue. The traffic came to a stop about half way through the stretch of road. My vehicle is already stationary when SKW 3157K, a Silver coloured Kia bumped into me from the back.

We pulled off to the left side of the road to inspect the damage and exchange particulars. Mr Low Han Kiat, IC No. 6829883J apologised and admitted that he was distracted by a motorcycle and overlooked what is in front.
