#### CIRCUMSTANCES OF ACCIDENT

The light was green and I was on the 4th lane(turning left towards Sheares Ave towards ECP, 4th lane is turning lane only). I noticed Rizal's car(R) very close to my car from my right side mirror before the traffic light stopped lines. I have slowed down to almost 30km/h before passing the dotted line at the traffic light, slowed down further to check for pedestrian crossing and ensuring I was not close to the turning car on my left as well. While checking my right side, before I can execute the turn on the dotted lines, R's car was moving ahead and cutting into my turning lane at a much faster speed. He sideswiped my right side front wheel arch, turning indicator and front apex corner of my bumper. I was too shocked to turn and hit the brakes to a stop to prevent further impact. He did not ensure the safety distant proximity of the left turning car, came too close to my turning car who was ahead of him, or should have slow down to check for crossing pedestrian. No one was injured and a passing police car took down the details that no injury of drivers and passengers. Police report A/20241206/0086 was filed by the policemen. Driver's names and details were exchanged and taken by police.
