CIRCUMSTANCES OF ACCIDENT

MY VEHICLE IS PARKED AT RISING COURT OSCP OF JOO CHIAT ROAD, I WENT TO RISING COURT ON THE 3Rd FLOOR TO HELP THE CILENT CARRY THEIR HOUSE THINGS DOWNSTAIRS. SUDDENLY I HEARD A DOWNSTAIRS COLLEAGUE CALL ME THAT MY PARKED VEHICLE WAS HIT BY VEHICLE B AND GOT ME TO GO DOWN TO TAKE A LOOK. HENCE, I WENT DOWN TO UNDERSTAND WHAT WAS HAPPENING WHILE I WENT DOWN MY COLLEAGUE TOLD ME THAT VEHICLE B TOLD HIM THAT WHEN EXITING FROM THE OSCP TO EXIT TO THE MAIN ROAD AND ACCIDENTALLY HIS VEHICLE REAR IGT PORTION COLLIDED WITH MY PARKED VEHICLE FROM RIGHT PORTION AND CAUSED DAMAGE AT THE SCENE VEHICLE B WANTED TO COMPENSATE FOR THE DAMAGE TO THE VEHICLE HOWEVER MY VEHICLE BELONG TO THE COMPANY AND HENCE HAS TO SEEK THE BOSS ADVICE AND INSTRUCTION, SO WE EXCHANGED PARTICULARS AND LEFT THE SCENE. AFTER MY BOSS CALLED VEHICLE B FOR THE DISCUSSION AND HE COULD NOT AGREE ON THE REPAIR COST THEREFORE HE GOT US TO PROCEED WITH INSURANCE CLAIMS

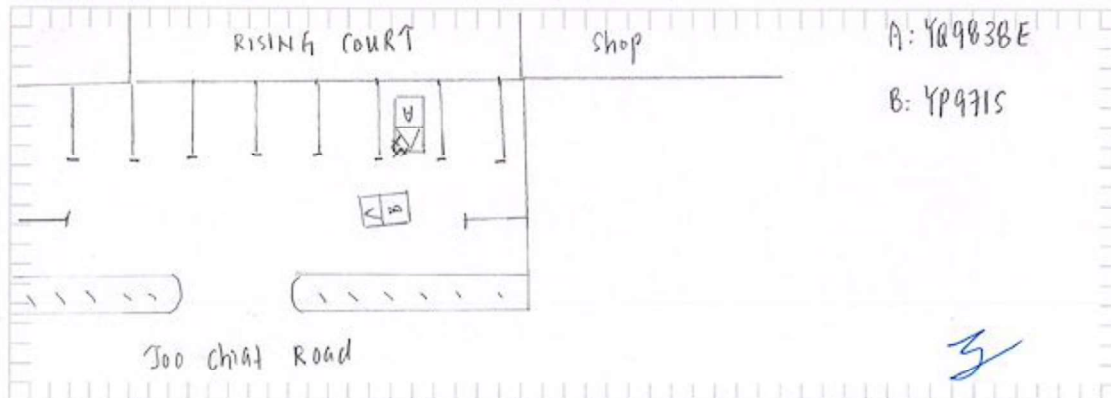

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

My vehicle is parked stationary at Rising Court OSCP of Joo Chiat Road.

I went to Rising Court on the 3rd floor to help the client carry their house things downstairs.

Suddenly, I heard a downstairs colleague call me that my parked vehicle was hit by vehicle "B" and got me to go down to take a look.

Hence, I went down to understand what was happening.

While I went down my colleague told me that vehicle "B" told him that when exiting from the OSCP to exit to the main road and accidentally his vehicle's rear right portion collided with my parked vehicle's front right portion and caused damage.

At the scene, vehicle "B" wanted to compensate for the damage to the vehicle however my vehicle belongs to the company and hence has to seek the boss's advice and instruction, so we exchanged particulars and left the scene.

After my boss called vehicle "B" for the discussion and he could not agree on the repair costs, therefore he got us to proceed with insurance claims.
