Upon reviewing footage from my car camera, I observed the following:
At 7:27 PM, the passenger of vehicle SND5965X opened the door wide, hitting my car and causing a dent.
The passenger then proceeded to sit in the car without closing the door first, which caused the edge of the door to scrape downward against my car, further damaging the paint.

My vehicle was parked well within my designated lot, with sufficient space for others to enter and exit their vehicles without the need to open their doors excessively wide.
