Brief Details.

Accident happened on CTE heading towards town before Ang Mo Kio Ave 1 Exit 11 . I was on my way to work at 8.30am when i got into an accident. I was riding a Yamaha R15 V2 plate number FBH6881T when i was side swiped by a Toyota Prius comfort delgro taxi plate number SH6184X , driver name is Lai Yuk Voon. I was in between lane 1 and 2 going at 80km/h to overtake a vehicle when the said comfort delgro taxi was in lane 2 . As i was about to pass him at that point i saw him signalled at the last minute to change lane to lane 1 and went to abruptly changed lane without checking his blindspot or mirrors which ended up in a side swipe of my vehicle and caused me to fall into lane 1 injuring my right arm with multiple abrasions and a fractured left toe with abrasions near my heel. Accident was witnessed by a passenger in the involved vehicle which is the comfort delgro taxi. Passenger name is Marsha and phone number is 86113644. Ambulance was called by witness and I was then conveyed to Khoo Teck Phuat Hospital.

Accident was handled by a LTA Traffic Marshal and a Traffic Police.
