7. **Discharge and Forms Authorization:**

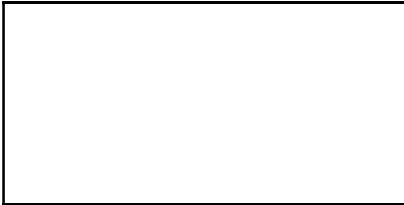
