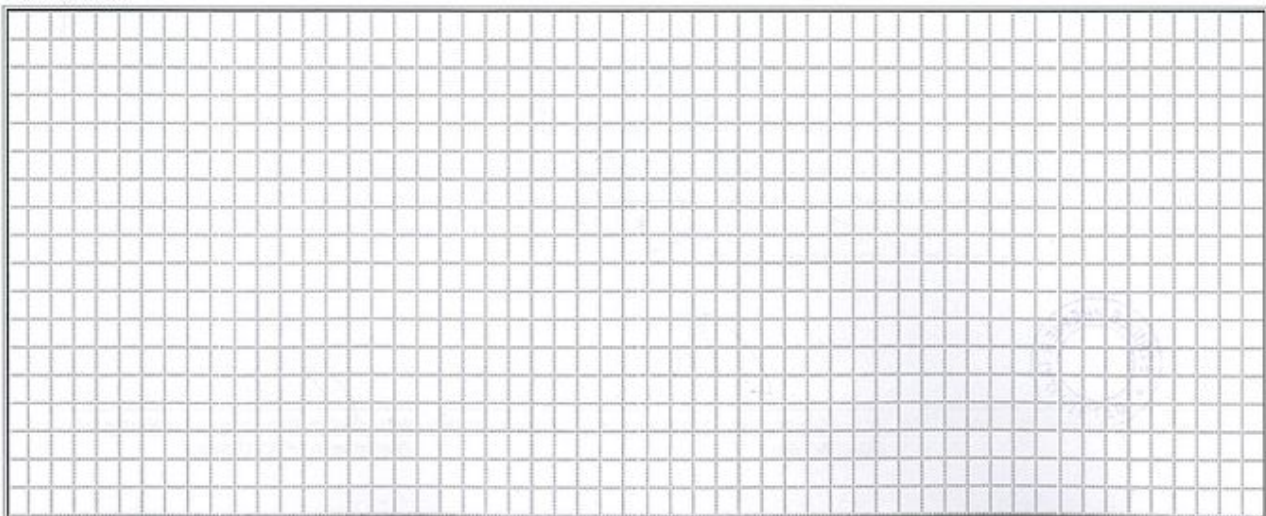

Sketch Plan

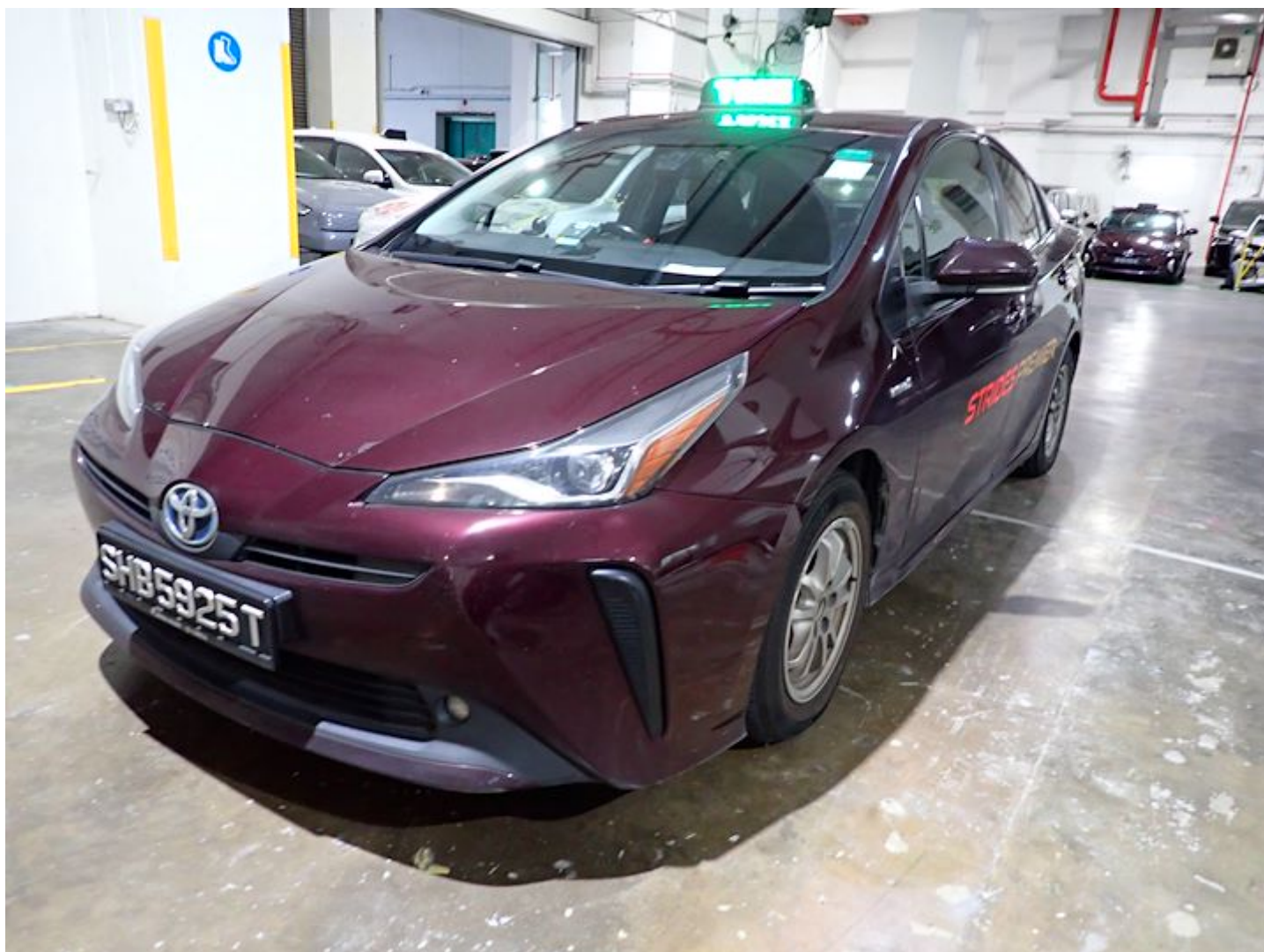

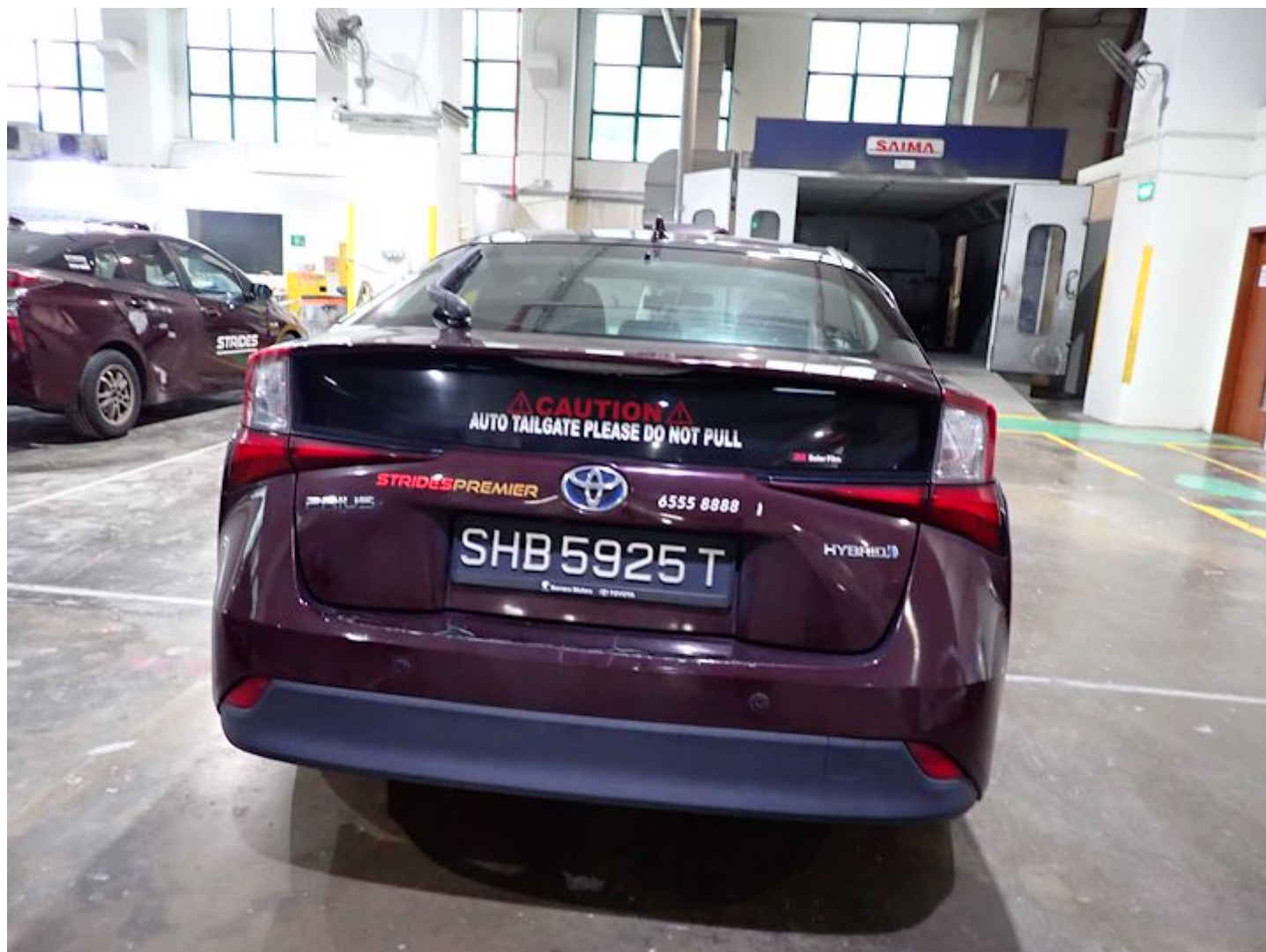










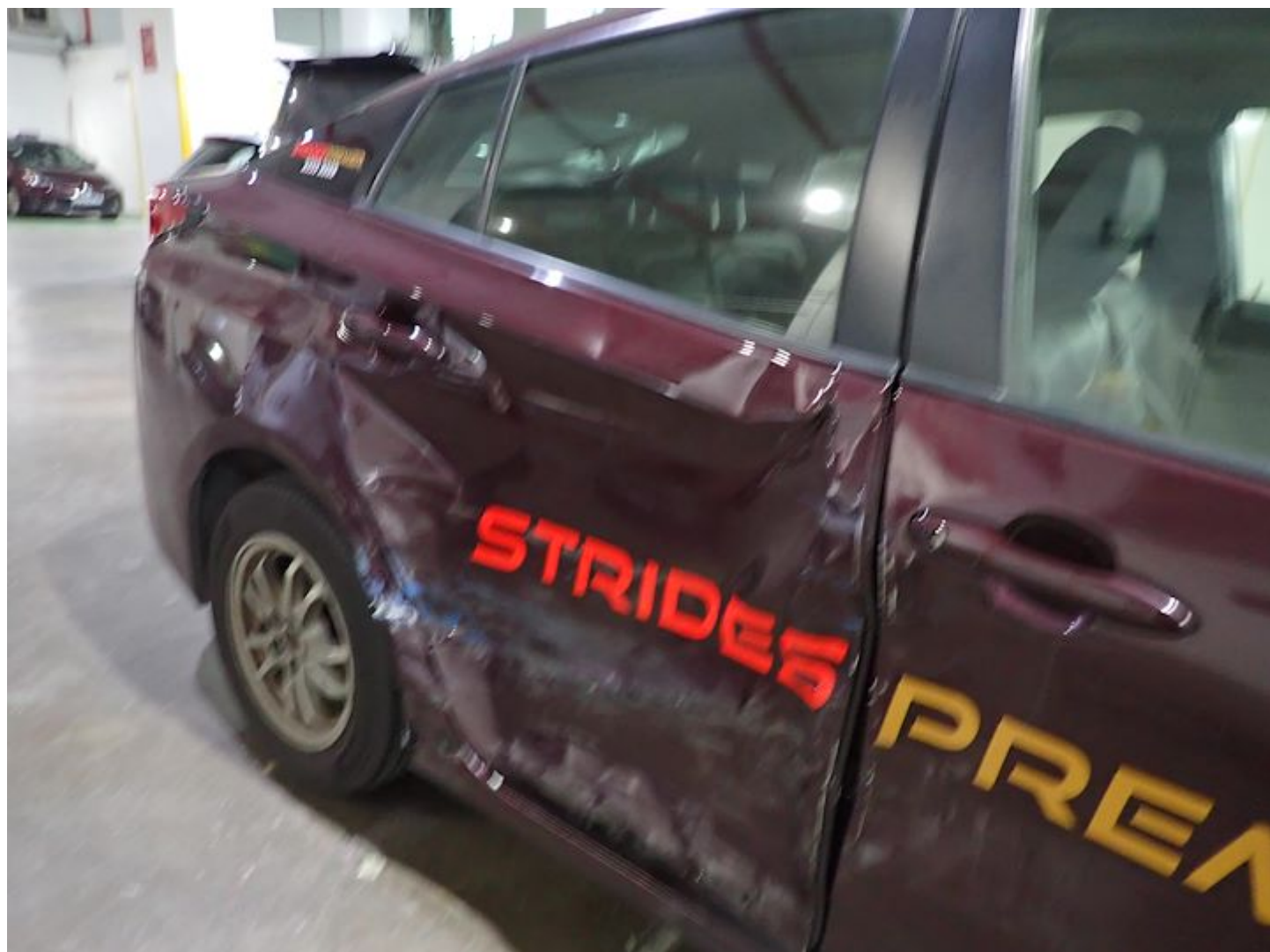
