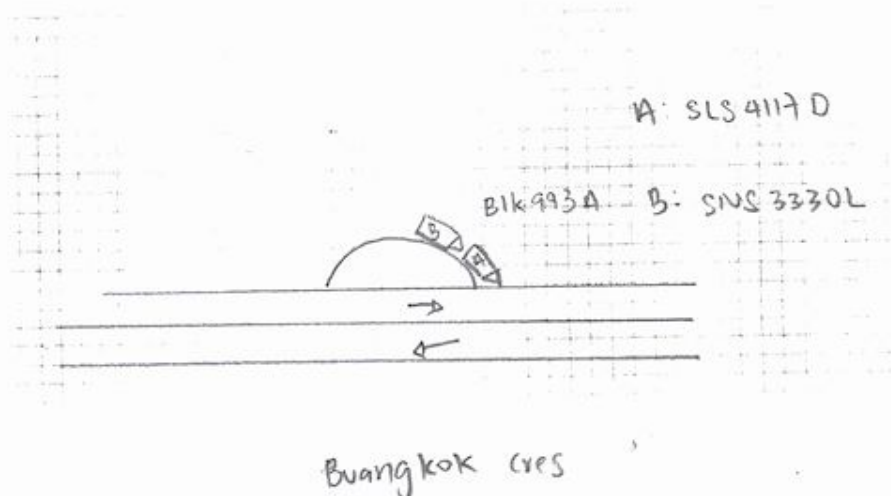

Sketch Plan







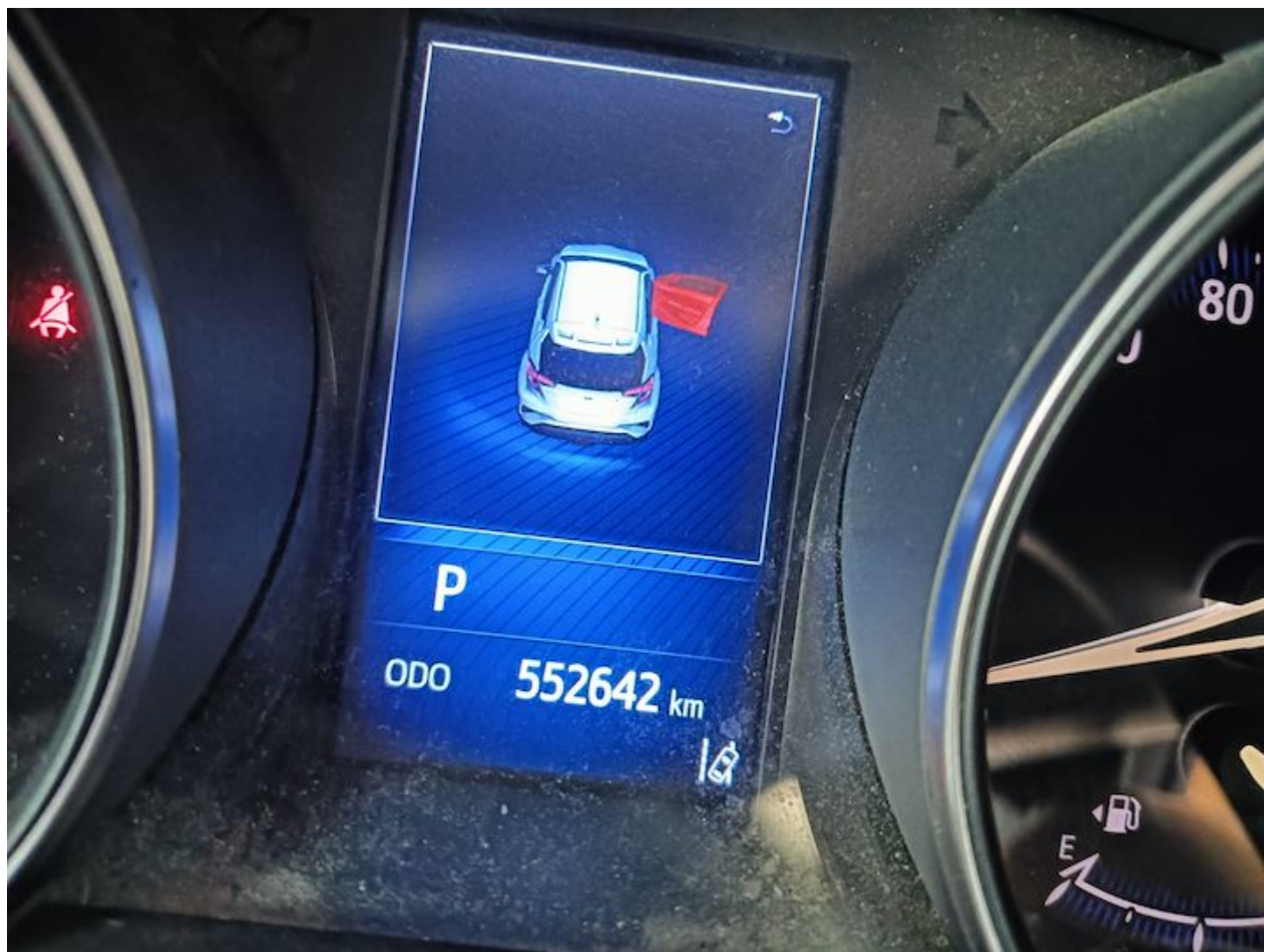
