#### CIRCUMSTANCES OF ACCIDENT

at 4:15 PM, I was making a U Turn at the Designated U turn junction outside gleneagles hospital. I proceeded as I saw lane one (the rightmost lane nearest the kerb) was clear and made small radius turn as the designated U turn junction had allowed my vehicle to make part of the turn. The other vehicle (SKM 302E ) was changing lane from second lane to lane one (right most lane) just at the same moment (which I wasn't aware) , no signal for lane change. I heard a bang as my car was almost completing the U turn and the car was swept rightwards onto the kerb. The other vehicle stopped about 100 meters down the road before the next U turn junction. My car does not have an in-vehicle camera.
