ON THE 22/12/2024 AT ABOUT 00:40HRS I WAS DRIVING VEHICLE A BEARING REGISTRATION NUMBER (SNF2356M) ALONG UPPER THOMSON RD EN-ROUTE FROM NEMESU AVE TOWARDS YIO CHU KANG ROAD TO PICK UP MY PASSENGER FOR WORK PURPOSE, AS MY VEHICLE WAS STATIONARY ALONG OLD UPPER THOMSON ROAD AFTER THE GREEN LIGHT, I PROCEED GOING STRAIGHT TOWARDS YIO CHU KANG ROAD SHORTLY AFTER, I FELT AN IMPACT ON MY FRONT RIGHT PORTION OF VEHICLE A AND REALISED VEHICLE B BEARING REGISTRATION NUMBER (SLX8599T) THAT WAS TURNING RIGHT WITHOUT STOPPING AND COLLIDED ONTO VEHICLE A FRONT RIGHT PORTION. 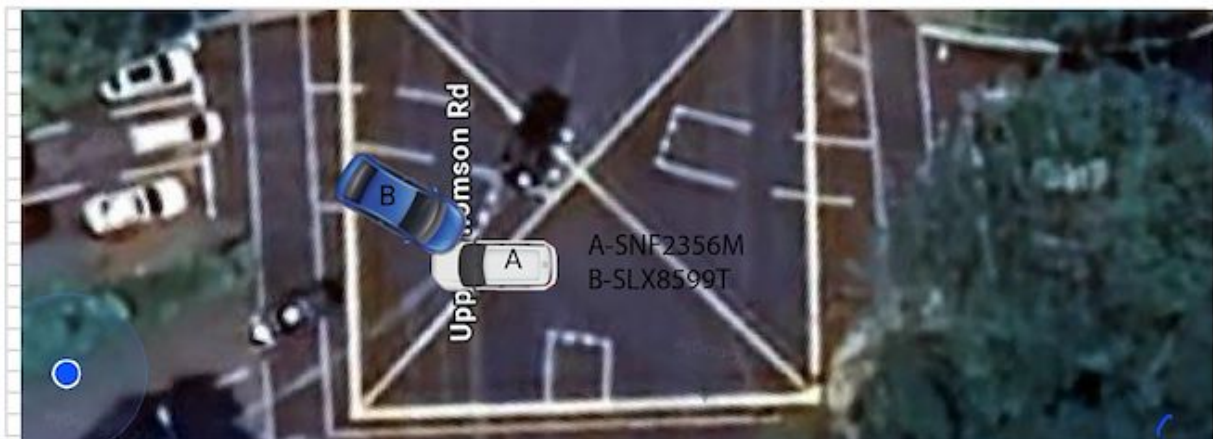
Sketch Plan
