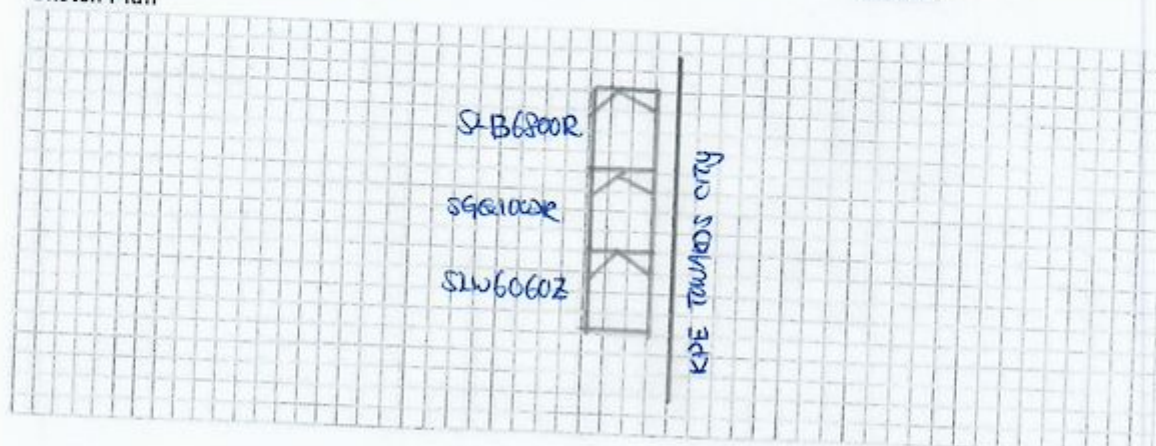

ACCIDENT REPORT

Location: KPE near lamp post 64 towards the City. Extreme right lane ie. Lane 1

Weather: Bright, clear, dry, sunny day

Traffic situation: Traffic jam as there was an accident somewhere ahead so traffic was very slow with frequent start/stops.

Cars involved: 3 cars with no injury

Car number 1: Front car - SLB 6800 R

Brown Toyota Altis, only driver in car

Driver: Lee Tiam Hong (S 0429392 D)

Car number 2 (our car): Middle car - SGQ 1002R

Black Mercedes GLA 180, driver and passenger (policy owner) in front seat

Driver: Ang Swee Hock Alan (S 1692360 G)

Car number 3 (car which started accident): Back/last car - SLW 6060 Z

White Peugeot, only driver in car

Driver : Dinesh Kumar Tiwari (S 8873695 H)

What happened:

As there was a traffic jam, we were moving very slowly with frequent gradual start/stops.

Somewhere around Lamp post 64 and in the inner most lane (Lane 1), Car number 1 and our car (car number 2) were moving extremely slowly (with our car number 2 preparing to stop when needed) when car number 3 crashed into the back of our car (car number 2). The impact caused our car (car number 2) to move forward and bump into car number 1. Car number 3 driver acknowledged that it was his fault and something about his slipper being caught in the foot paddles.

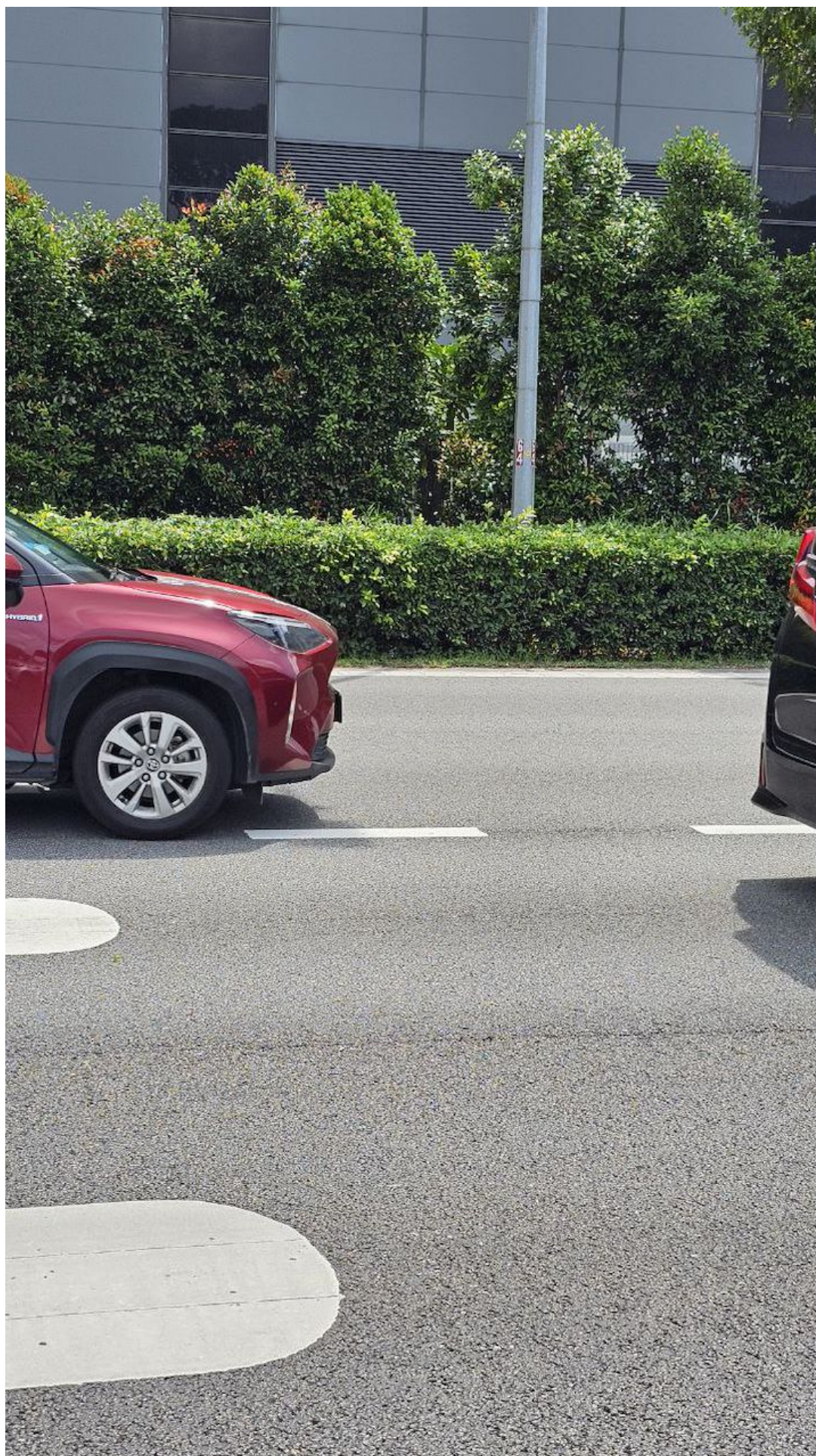




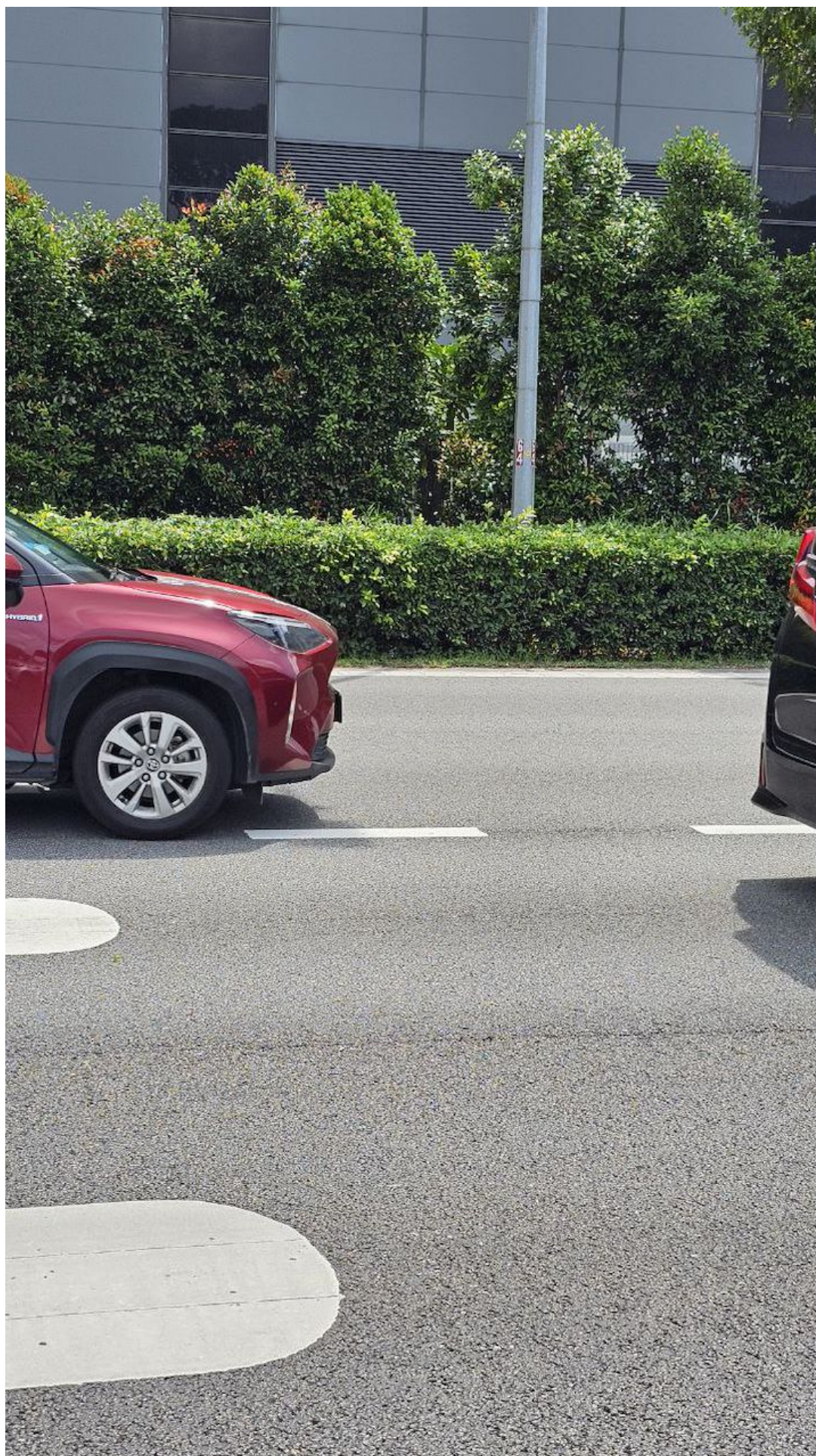


















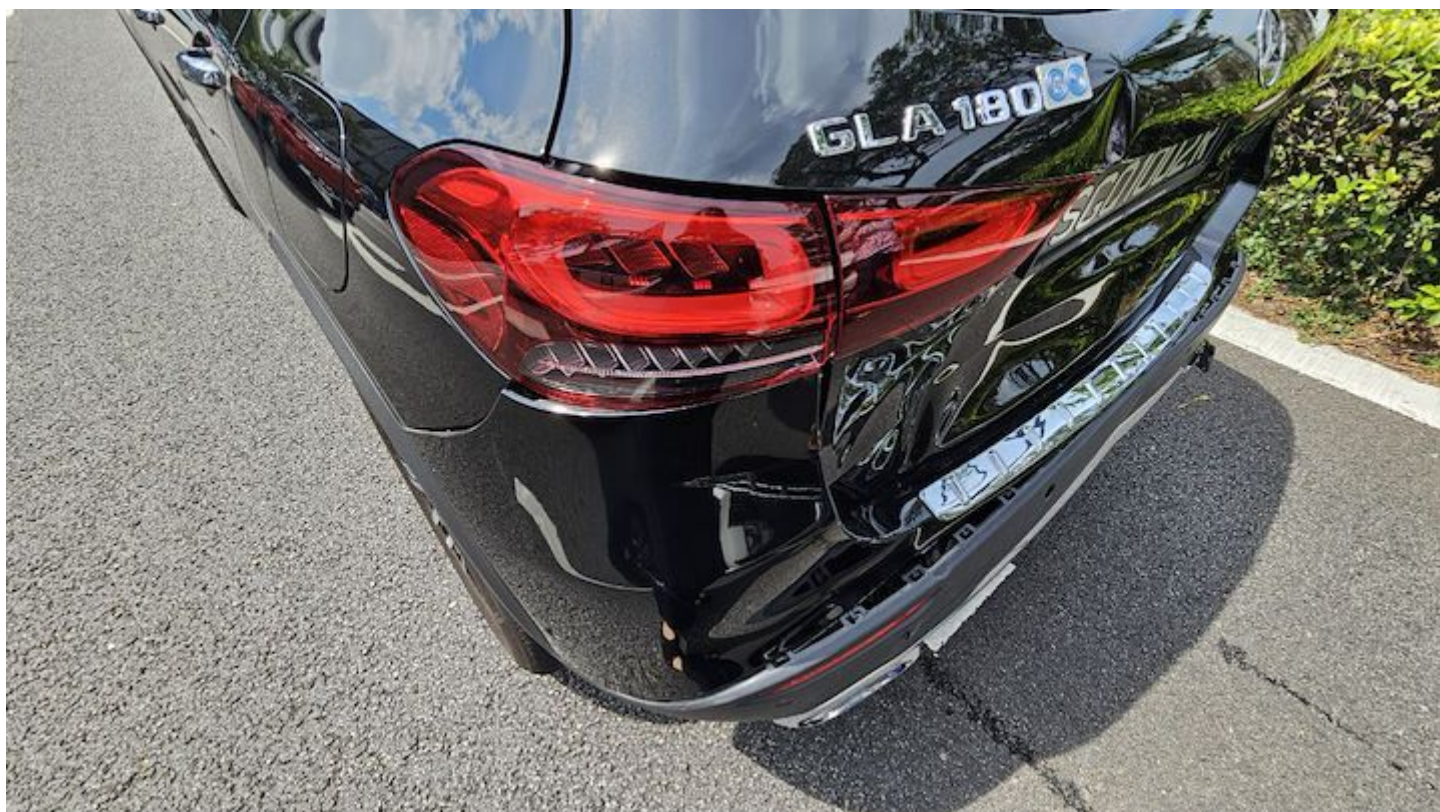
