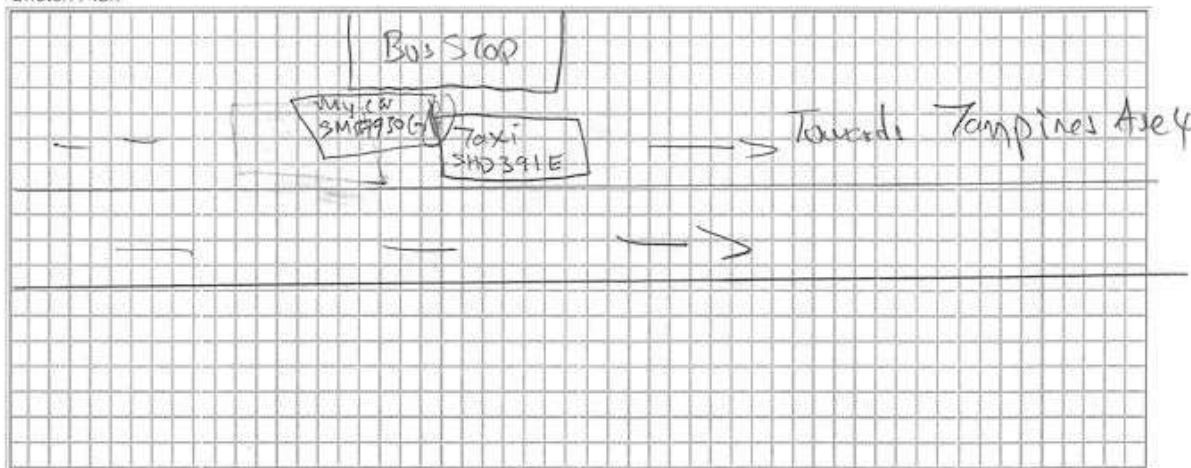

**NOTICE OF REPORTING**

This is to confirm that Tan Zhenqiang H/P: 98538995, NRIC/FIN: S8200896I has reported to the Police a non-injury traffic accident which occurred along Tampines Avenue 4 towards Tampines Central at the left lane on 09/07/2023 at 0901hrs involving the following vehicles:
