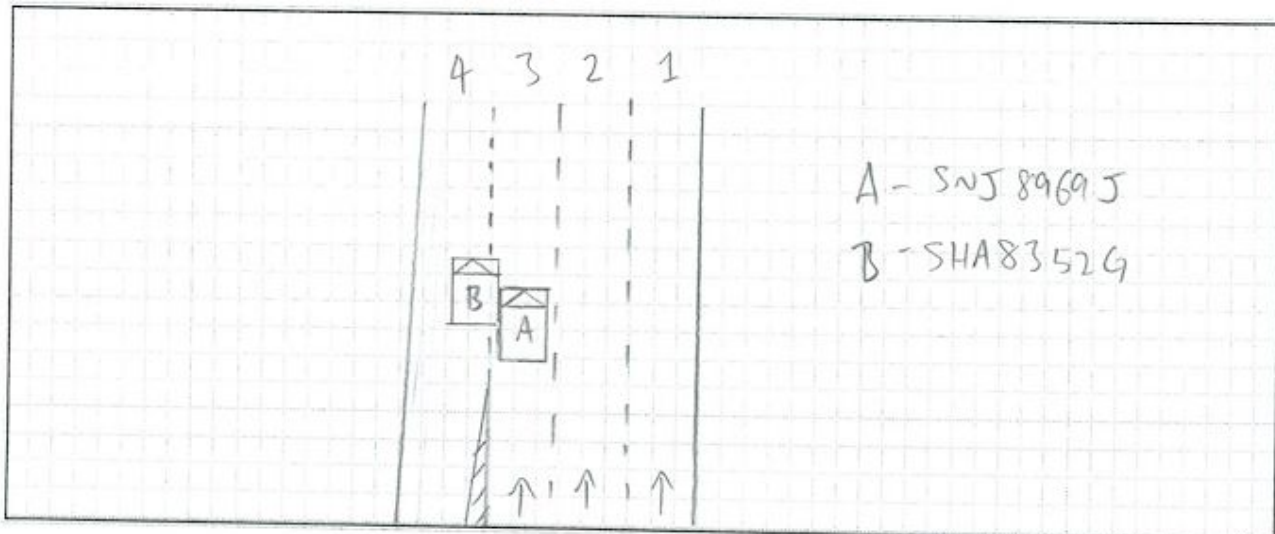

Describe Circumstance of the Accident

On June 28th at approximately 11:40pm, I was driving towards Terminal 4 on the pie (Pan Island Expressway). While driving, I suddenly heard a sound from my rear car sensor. When I looked in my rearview mirror, I saw a taxi approaching at an aggressively fast speed behind me. The taxi then abruptly steered to ^{the} right lane and dangerously kept a close distance to my vehicle.

Suddenly, I felt an impact from the left side of my vehicle and realised that a taxi emerged from a minor exit lane at high speed and collided with my vehicle. I am confident that I was in my lane and had the right ^{of} way. The taxi driver quickly called his friend, and several other taxis arrived at the scene shortly after. We both confirmed that we did not suffer any injuries but I would add in that this might be a staged accident. The taxi driver suggested a private settlement, which I believed ^{the} the accident was not my fault. I later learned that he had made a report when I called the next day.
