

Describe Circumstance of the Accident

After the cross junction of Upper Aljunied Rd/ Upper Serangoon Rd, I signaled right to filter right to to ~~move~~ avoid bus lane. I checked rear view mirror and right side mirror again, then slowly filter on to a lane on the right. Suddenly, there was a loud 'bang' sound as a vehicle passed by very fast on my right. That vehicle was very fast and took a while to halt at a distance ahead, just before the bus bay. I alighted, checked vehicle: right side mirror was damaged as well as the right side of the vehicle. Driver of the other car (SMZ 3279 C) alighted. As I approached him, he said, "what happened, huh?" I took video and photos of both vehicles and location of accident. We took photos of both parties' ICs and exchanged contact numbers.
