Brief Details.

I am lodging this report vide T/20240126/2041 to add further information for my insurance claim. I do not require any investigation.

On 26/01/2024 at about 0800hrs, I was riding my bike (FBQ2517A) along AYE towards MCE. The traffic was heavy, and I was lane splitting in-between lane 1 and 2 when a car (SMX3671M) out of a sudden switched from lane 2 to 1 without signaling causing me to apply emergency brake on my bike. Unfortunately, it was too close and I collided onto the rear right-side of the car. The collision was between the front wheel of my motorcycle and the rear right-side bumper of the car. The incident was witnessed by a rider who was behind me. The car also had an in-car camera recording mentioned by the driver. I exchanged particulars with the driver and also took some photographs of the accident before proceeding off from scene. No ambulance or police attended to my accident.

I wished to state in the report that during the accident, my motorcycle fell on the left side on
