I have made a report on the above mentioned accident and would like to include additional information or make the following amendments:

Upon checking the in-car camera, we noticed a file in the 'events' folder. This showed the date and time of the incident, as well as the registration plate of the vehicle SFP 6599U that hit our car. We went to the residence and talked to the condo security.

They contacted the driver and he came down to meet us. The driver, (Glenn Kelvin Yeo Kuo Kuang NRIC S7913182B), in the presence of the security guard, admitted he had hit our car, and that he had driven off without leaving a note because he was in a hurry

and thought that he could contact the owner upon his return. We took pictures of our damage and the parts of his car that hit ours. The video shows his car immediately after that incident and also of him driving against the assigned direction of traffic. He offered us

a "Private Repair Settlement Form" and to pay 100% of the repair costs but we refused. We have photographs, the video, and the Settlement form signed by him, but not us. We also filed a police report and have that too
