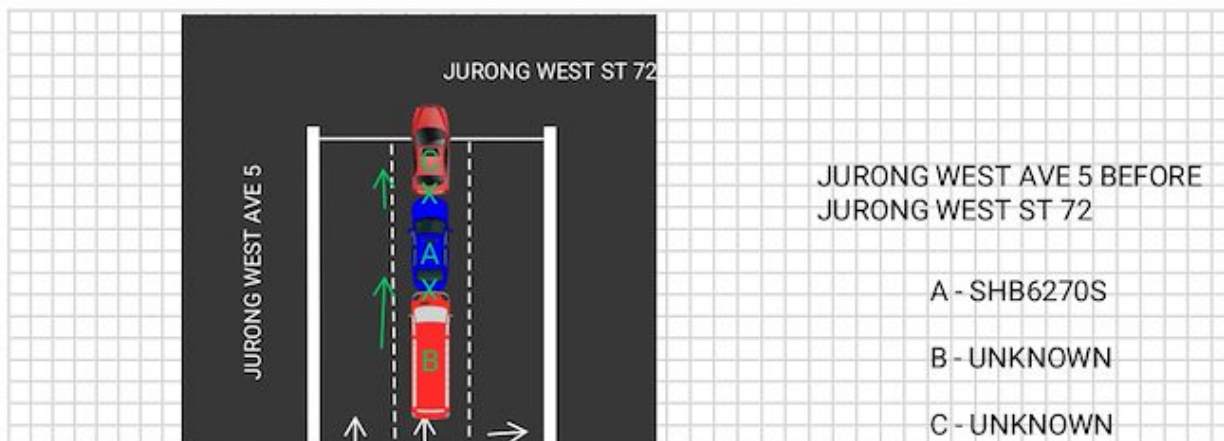

Brief Details.

On the above mentioned date, time and location, I was driving my Comfort Delgro taxi bearing registration number SHB6270S along Jurong West Ave 5. I came to a complete stop at a red traffic light behind one red coloured car at the junction of Jurong West Ave 5 and Jurong West St 72. While waiting at the traffic light, I felt a huge impact coming from the rear of my vehicle. After the impact, I was in pain and could not move and therefore remained in my vehicle. I managed to catch a glimpse of the vehicle that had struck my taxi and had established it to be a white bus, however I was unable to take note of the registration number. A short while later, I was approached by a member of the public who assisted to contact for assistance. Subsequently I was conveyed to National University Hospital where I was given a total of three days outpatient sick leave.

I wish to state that my vehicle has a working front and rear facing in-car camera.
