CIRCUMSTANCES OF ACCIDENT

I TURNED LEFT FROM JALAN JURONG KECHIL TO JALAN RAJAWALI, DROVE STRAIGHT FOR ABOUT 30-40 METRES BEFORE TURNING RIGHT INTO GRAND CHATEAU CONDO. I INTENDED TO MAKE A 3-POINT TURN TO GO IN THE OPPOSITE DIRECTION AS I WANT TO RETURN TO JALAN JURONG KECHIL ROAD TO GO ONTO UPPER BUKIT TIMAH ROAD. I LOOKED TO MY LEFT WING MIRROR AND TURNED MY HEAD BACK LEFTWARDS TO CHECK MY LEFT BLIND SPOT. SEEING THAT THERE WAS NO CAR, I PUT MY CAR IN REVERSE GEAR AND STARTED BACKING UP SLOWLY AT THE SPEED LESS THAN 10 KM/H. I THEN FELT A COLLISION INTO MY REAR AND THE SAID BMW X1 CAR BANGED QUITE HARD INTO MY REAR AND BROUGHT MY CAR TO A HALT



I turned left from Jalan Jurong Kechil to Jalan Rajawati, drove straight
~~for~~ ~~and~~ about 30-40 metres before turning right into Grand Chateau Condo.
 I intended to make a 3-point turn to go in the opposite direction as I
 wanted to return back to Jalan Jurong Kechil road to go onto Upper Bukit Timah
 Road. I looked to my left wing mirror and ~~started~~ turned my head ~~left~~ back ~~left~~ ~~back~~
 to check my left blind ~~spot~~. Seeing that there was no car, I put my car
 in reverse gear and started backing up slowly at a speed of less than 10 km/h.
 I then felt a collision into my rear and the said BMW x1 car banged quite hard into
 my rear and brought my car to a halt.
