Thank you for your reply

We have checked our records and we are unable to trace your reporting of the accident to our office. 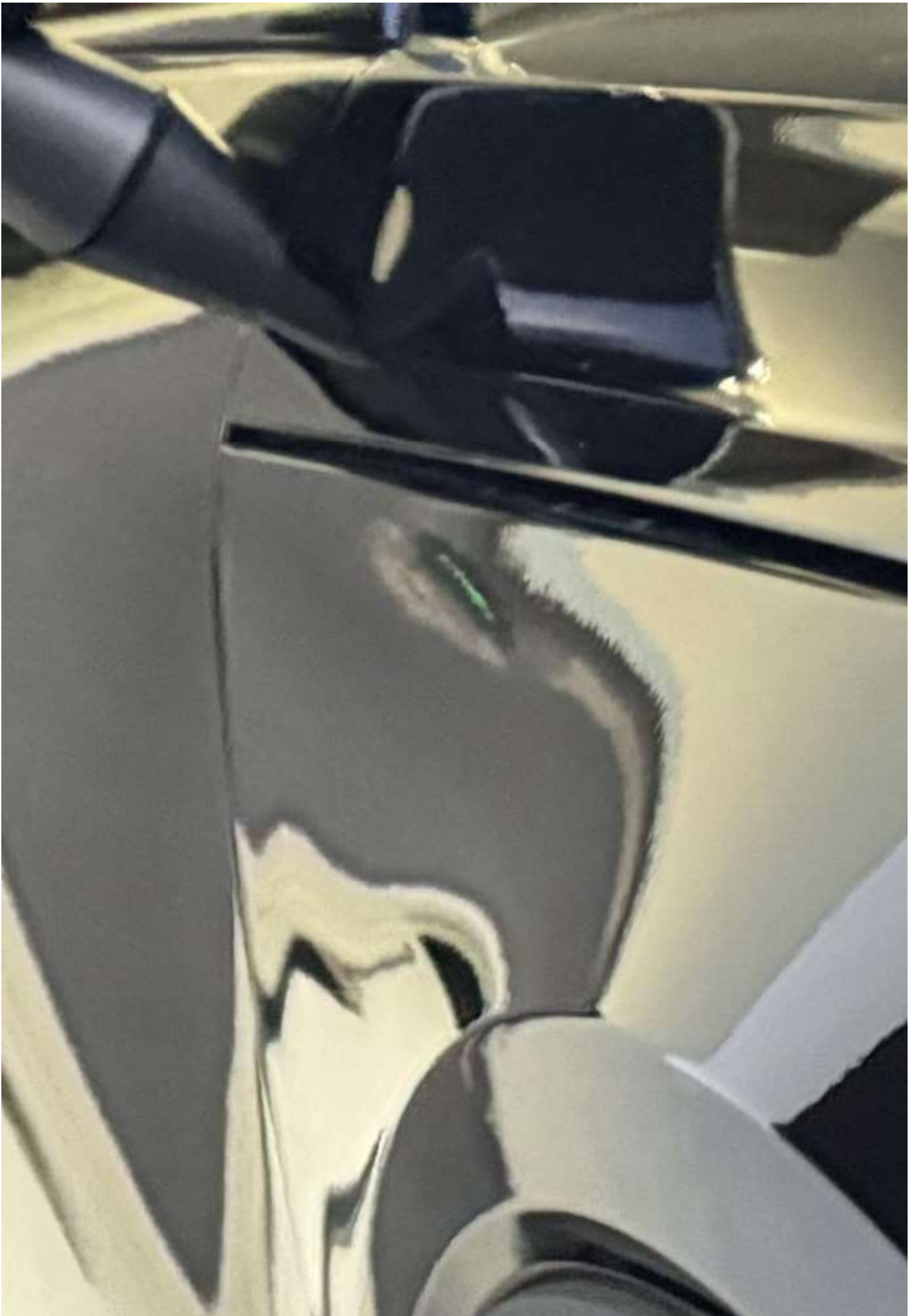



Brief Details.

On 19 July 2024, 12:05PM, I was driving on Pasir Ris Drive 8 and turning right to Ris bus interchange and to TPE. Upon turning into Pasir Ris Drive 3 at around line of car queuing to turn right into Pasir Ris Central, my car SLS6215R was behind, rear left side. The vehicle involved in the accident was attempting to overtake and its front collided with my vehicle rear bumper, left side. This happened at the rear left side of my vehicle right side). After the collision, I immediately parked my vehicle at the side of the road and stepped outside the vehicle when the involved driver drove her vehicle away quickly.
