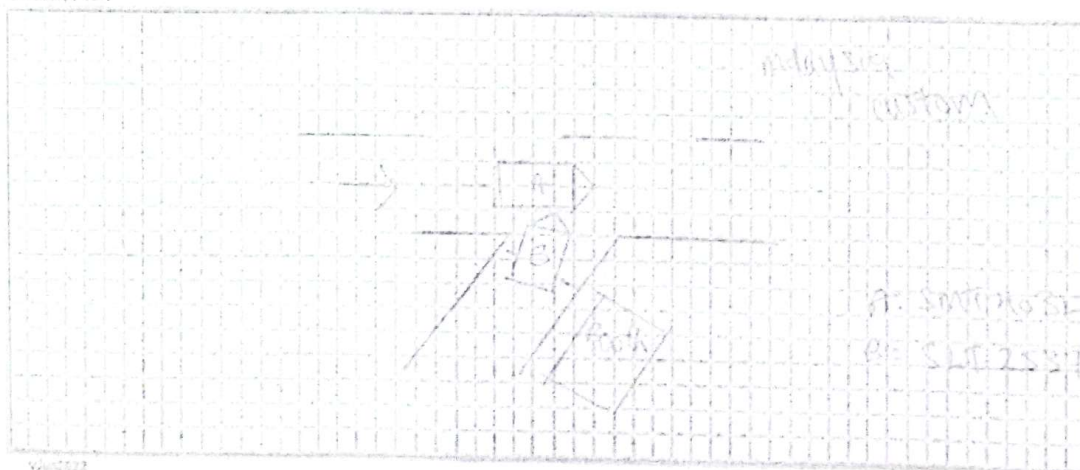

AFTER I WAS CLEARED FROM THE CUSTOM, I WAS DRIVING ALONG THE DRIVEWAY. SUDDENLY VEHICLE B (SLT2537H) DASH OUT FROM 1 OF THE BOOTH (AFTER THE BARRIER LIFTED) WITHOUT GIVE WAY TO ME THUS COLLIDED ONTO THE RH PORTION OF MY VEHICLE.

DUE TO IMPACT, MY VEHICLE WAS DAMAGE ON THE RH PORTION.

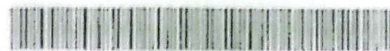
