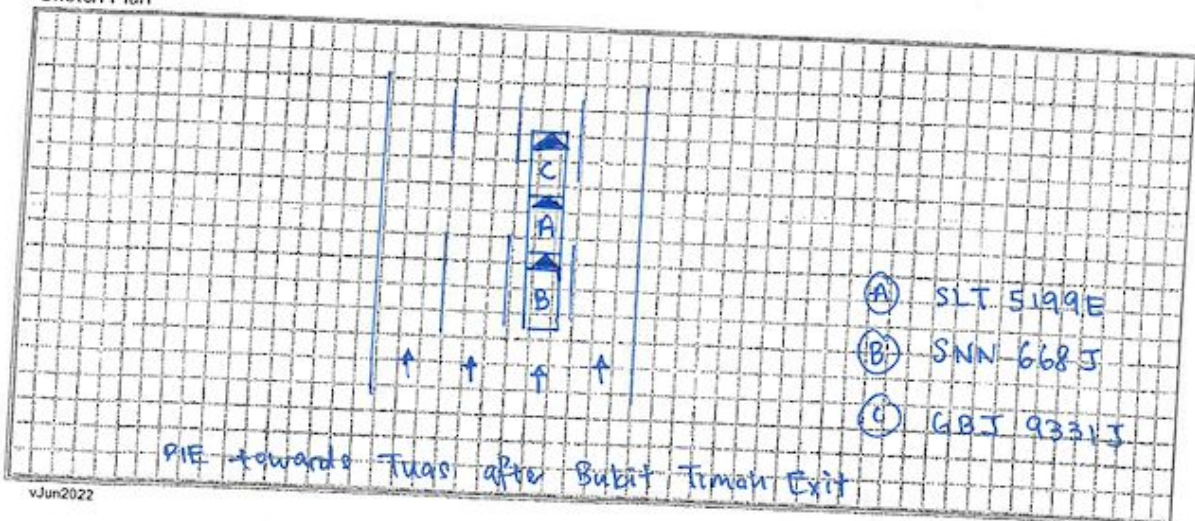

I alighted from my car and realised I was involved in a 3 car chain collision.
