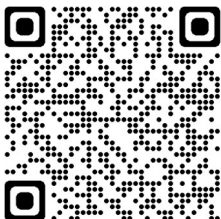

CIRCUMSTANCES OF ACCIDENT

On the mentioned date and time, I was informed by IS Gendrick Tan that I had involved in an accident with vehicle MID21536 on 24 July, at 11:13am at bus stop 59739. Upon reflecting on the events of that day, I recalled that on 24/7/24, a grp of military trucks had passed by my stationary bus at the mentioned bus stop. I was engaged in loading and unloading passengers at this bus stop. This particular bus stop only can accommodate one bus at a time. While performing my duties, I noticed an elderly passenger waiting at the bus stop. To ensure safe boarding, I decided to position the front door of my bus closer to the curb. During this maneuver, I did not notice any contact between my bus and the military vehicles. At no point did any of the military truck drivers approach me regarding an accident, nor did I observe any damages to rear of SG5021U. Given my lack of awareness of any collision or accident, I did not report to OCC. 20-30Pax onboard. No injury reported. That's all.
