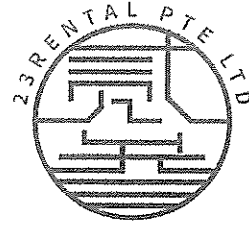

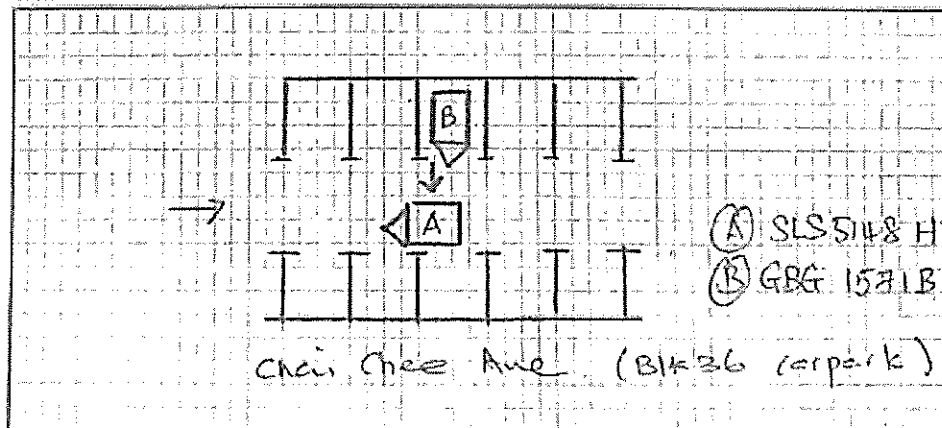

Sketch Plan

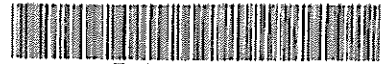
