Brief Details.

On 25/7/2024 at around 5.15pm, I was driving my company's vehicle GBE6151H along Woodlands Ave 12 towards Gambas Ave. I was stationery on lane 2 at T-junction of Woodlands Ave 12 & Ave 5.

When the traffic light turned Green & I started to move my vehicle GBE6151H, suddenly I felt a huge impact from the rear of my vehicle. The great impact pushed my vehicle forward and hit on GBF5463J who was in front of me. The impact was huge hence I was injured and felt pain on my neck and back. I couldn't alight from my vehicle and someone checked on me and called for ambulance.

I was conveyed to Woodlands Health Campus and admitted on 25/7/2024. I was discharged on 29/7/2024 and was given 25days of MC from 25/7/24 to 18/8/24.

This was a 3 vehicles chain collision. Vehicle XB9775T who hit onto my vehicle GBE6151H and the impact pushed me to hit on GBF5463J.
