Brief Details.

On 19/07/2023 at about 2110hrs while driving my taxi bearing registration number SHA8282A, along Jalan Bukit Merah with no passengers on the right most lane with the intention to turn right to Jalan Kilang Berat. I stopped my vehicle to check for any oncoming traffic and saw that the road was clear. I then proceeded to make the right turn towards Jalan Kilang Berat when suddenly a motorbike bearing registration number FBC7315G collided with the left front side of my vehicle. I then immediately called for police and the rider was subsequently conveyed by ambulance and I was attended by police. I was unable to get the rider's details and subsequently handed over my vehicle camera SD card to the traffic police officer that attended to me.

Later on, I received a phone call from 91994511, who informed that they were the rider's NOK and asked me if I knew where the rider's phone and wallet were. I told them that the phone was with the police but I did not see any wallet.
