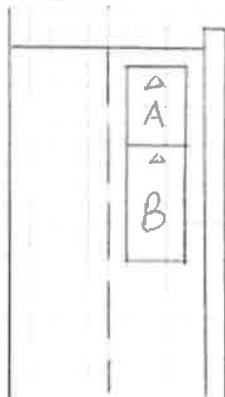

Brief Details.

On the 04/08/2024 at about 1.40 pm, I was driving my motorcar no. SKX 3061 Y with my wife, Ang Shi Ting. Cynthia (NRIC No. S8007565/J) as a front seat passenger along Sembawang Drive towards the direction of Admiralty Road West. I came to a stationary position as there was a red traffic light at the pedestrian crossing near lamp post no. 31.

A few seconds later, a motorlorry no. GBD 3793 E came very fast from behind and violently hit onto my motorcar causing very serious damaged to my rear until the whole rear windscreen was shattered and both me and my wife, Ang Shi Ting, Cynthia suffered serious injuries to our neck and lower back because of the violent impact.

I have the front and rear video footages of the accident which I can furnish to the traffic police investigator.

I and my wife seek medical treatment at Family Care Clinic for our serious injuries and was given 3 days of MC for each of us. I am still in pain and will ask for extended MC once my MC finish. I enclosed herewith the 2 MCs of me and my wife.

I wish to claim against the insurance company of the motorlorry no. GBD 3793 E for me and my wife serious personal injuries, the serious damages to my motorcar and other consequential losses.
