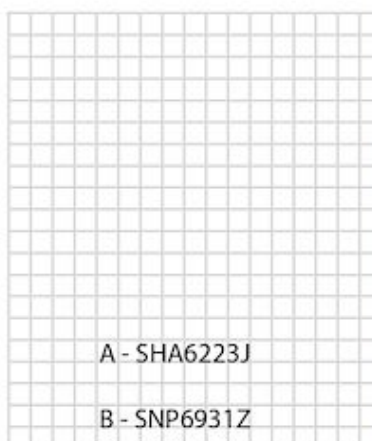
Sketch Plan
