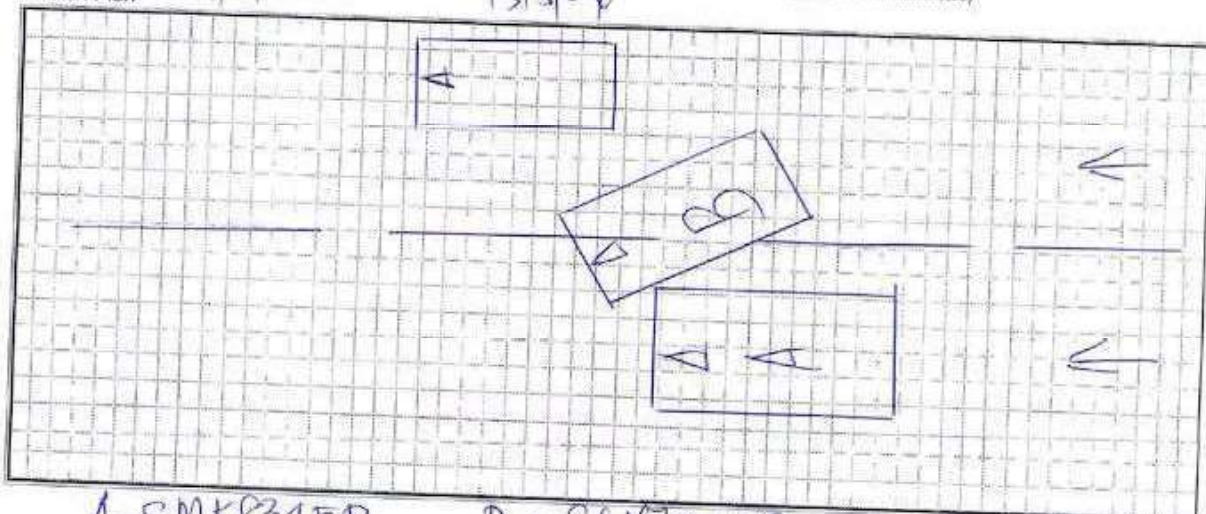
Sketch Plan

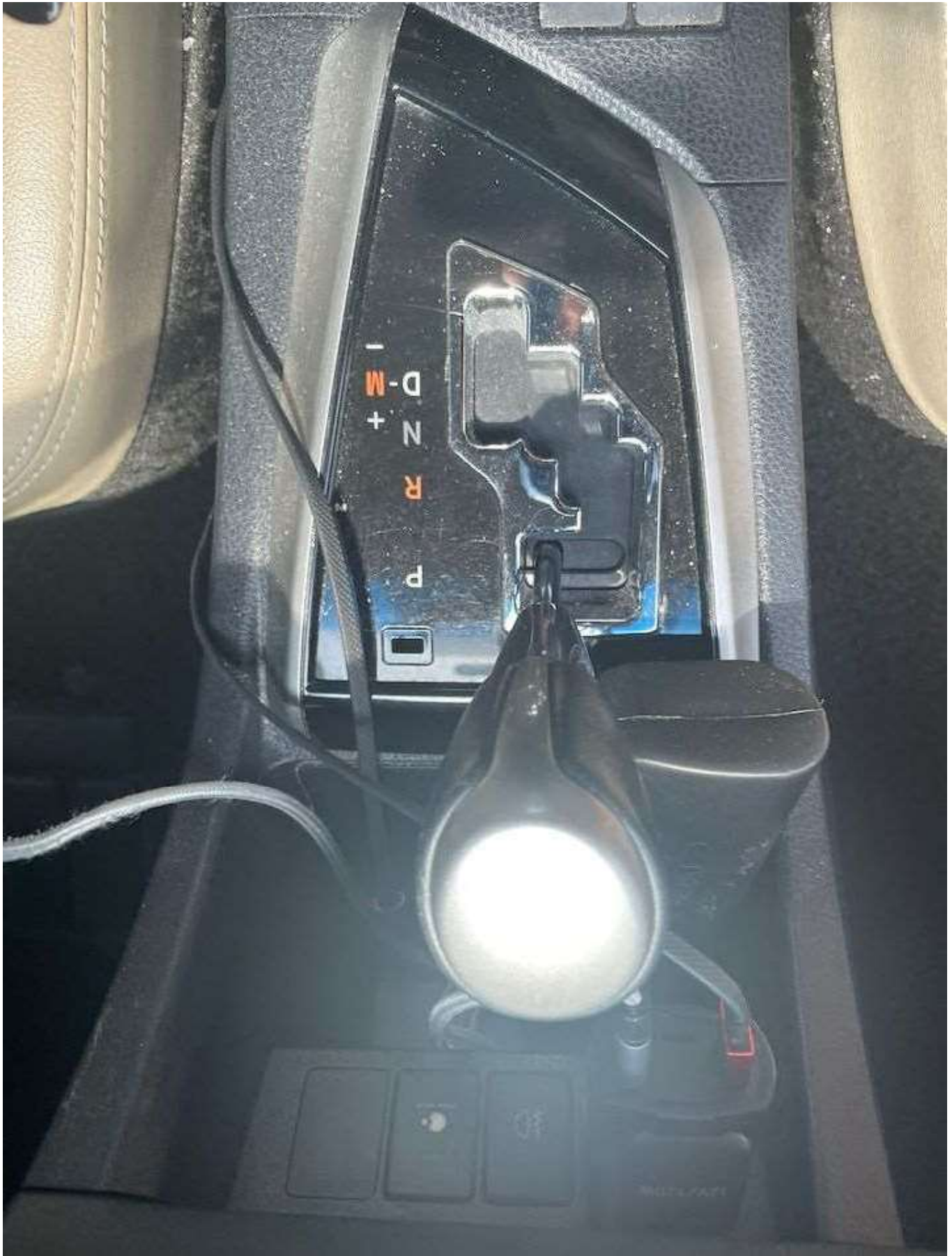
