Brief details.

I was riding out from the exit gantry between Blk 84 and Blk 88, just passed a road bump towards Bedok North St 4. I slowed down to check for pedestrians at the zebra crossing, no one at the zebra crossing and I proceed to ride past the zebra crossing and the road bump. A garbage vehicle suddenly drove out on my left via the pedestrian walk way from under the housing blk. With little to no reaction time, we collided. I hit the right side of garbage vehicle. I flew forward and hit my chest against the vehicle causing 3 ribs fractures upon impact. I have a witness who saw the whole scenario from before the accident to when the accident happened. I saved his contact number. I called the ambulance and police, and left the scene after ambulance came and picked me up.
